1. The DSSSB vide its advertisement number 02/2014 with closing date 25/01/2015, had advertised 47 vacancies (UR-42, OBC-03, SC-01, ST-01 including 01 HH ExSM-05 and SP-02) for the Post of Stenographer, Grade-III in Services Department under Post Code 211/2014 which were further increased to 349 vacancies (UR-173, OBC-100, SC-36, ST-40 including VH-07, HH-01, OH-04, ExSM-42 and SP-02) vide addendum dated 07/06/2018. Board Conducted Tier I Written Examination for selection to the Post along with similar Post Codes on 11/06/2017. Board had declared marks of Tier I written examination of the Candidates of the Post of Stenographer, Grade-III in Services Department under Post 211/2014 vide notice number 550 dated 06/10/2017.
2. The DSSSB vide Result Notice No. 707 dated 25/08/2018 and 749 dated 13/12/2018 has provisionally selected 156 candidates for the post of Stenographer, Grade-III in Services Department under Post Code 211/2014
3. Based on the performance in the One Tier Examination, 666 candidates were shortlisted for appearing in the Phase II of shorthand and typewriting skill test vide notice no. 708 dated 25/08/2018 and 751 dated 13/12/2018. The Skill test for shorthand and typewriting was conducted with effect from 04/01/2019 to 06/01/2019, wherein 489 candidates have appeared. The result of skill test was declared vide notice no. 785 dated 20/05/2019 and corrigendum no. 788 dated 23/05/2019.
4. Candidates having roll no. 14316760, 14316656, 14316582, 14316899, 14317147, 14316863, 14316967, 14316972, 14317076, 14316584, 14317126, 14317274, 14317055, 14316588, 14316546 who, qualified in Phase-I Skill test held between 08/02/2018 to 11/02/2018 have been shortlisted for Post Code 211/14 as per cut off marks in respective category.
5. The Board has adopted the criteria for evaluation of the skill test on the pattern of SSC and considered up to 7% mistakes in Shorthand skill test for UR category and up to 10% mistakes in Shorthand skill test for all reserved category candidates, as qualified with a speed of 80 w.p.m. As per RR for the Post the candidate was to Qualify the 40 w.p.m. in Typewriting in English or 35 w.p.m. in Typewriting in Hindi, as well
6. As per RRs for the Post the candidate was to qualify the 40 w.p.m. in typewriting in English or 35 w.p.m. in typewriting in Hindi.

7. After preliminary scrutiny of the candidature of the candidates on the basis of documents uploaded by them in their e-dossier as per the provisions of the statutory Recruitment Rules for the Post and the terms and conditions of the advertisements, the following candidates are provisionally selected to the Post of Stenographer Grade III in Services Department under Post Code 211/2014.

8. No other suitable candidates found for selection in ST, PH (OH), EXSM and Sports Category.

9. Candidature of 02 candidates having roll no. 14311293 (UR) and 14308805 (SC) are rejected for failing to upload their e-dossier during the scheduled time, i.e., 22/05/2019 to 31/05/2019.

10. Candidature of 01 candidate having roll no. 14316899 is rejected in UR Category as their % of error in shorthand skill test is more than 7% and thus not qualified the shorthand skill test as per UR Category criteria.

11. Candidature of 01 candidate having roll no. 14313780 is rejected as he has OBC outsider certificate and as per his marks he has scored below the cutoff marks of UR category.

12. Candidature of 02 candidates having roll no. 14317147 and 14316967 is kept pending for want of mark sheet and certificate of 12th pass or equivalent under 10+2 system from recognized Board/University, required as per statutory RRs to the Post. Further, the OBC

(Delhi) Certificate of candidate having roll no. **14316967** is also required for consideration of candidature in OBC Category.

13. Candidature of 01 candidate having roll no. **14316546** is kept pending in SC Category for want of SC Certificate.

14. Candidature of 01 candidate having roll no. **14304695** is still pending in UR Category as the candidate had furnished the higher secondary certificate. Candidature is pending for seeking clarification from the User Department regarding admissibility of the said qualification for the post.

15. Candidature of 01 candidate having roll no. **14304000** is still kept pending in Sportsperson category for seeking the clarification from Sports Authority of India as to whether the Amateur Cricket Federation of India a recognized Federation at a National Level and whether the sports certificate issued by the said federation can be considered for selection of candidate to civil posts under sports person category.

16. Candidature of 01 candidate having roll no. **14300188** is still kept pending in OH category to determine the admissibility of the typewriting exemption claimed by the candidate.

17. The Selection of the above 53 candidates (UR-10, OBC-20, SC-23) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide **MHA OM No. 2/29/54-RPS, 19/11/54.**

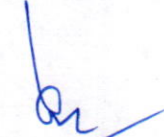
18. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency notices in the documents of the candidate at their own level.

19. It is stated that the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
20. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/08/2008.
21. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms *vis-à-vis* the original documents. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
22. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
23. If the candidate has any grievance regarding his/ her educational qualification/ age etc., he/she may approach the user department i.e. Services Department, GNCTD for necessary clarifications as the eligibility has been checked as per the terms & conditions provided by the user Department.
24. The result is subject to the outcome of the court cases pending, if any, in various courts related to this post.
25. Further, waitlist/panel for the post code 211/14 shall be valid up to 16/06/2020.
26. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
27. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any.
28. This issues with the prior approval of the Competent Authority.
