ORDER

- This order shall dispose of the representation dated 23.06.2021 filed by Sh. Deepak, Ex-FSI/Gr.II(DASS), Food Supplies & Consumer Affairs Department in compliance of the directions of Hon'ble CAT order dated 04.10.2021 in OA No. 2194/2021 in the matter of Sh. Deepak Vs. GNCTD of Delhi & Ors.
- 2. The Hon'ble CAT while disposing the Original Application no. 2194/2021 has directed to the respondents to decide the pending representation of the applicant dated 23.06.2021, within a period of 03 months from the date of receipt of a copy of this order, by passing a reasoned and speaking order, under intimation to the applicant.
- 3. The applicant vide his representation dated 23.06.2021 has prayed as under:-
 - That After selection for the post code 40/13, Grade-II (DASS)/ASO, Services Department the applicant Sh. Deepak joined the Department of Food Supplies & Consumer Affairs as Grade-II (DASS)/FSI. He also appeared in an exam for post code 16/17 & 01/18. Teacher Primary, MCD in which DSSSB has found that he was indulged in unfair means during the exam. Therefore DSSSB vide order dated 17.03.2020 has debarred him from any examination conducted/to be conducted for life time w.e.f. 30.09.2018 and further his candidature was deemed cancelled if he had appeared in any exam conducted prior to above date. On the basis of debarment order Department of Food Supplies & Consumer Affairs terminated his services vide order dated 30.09.2020. His grievance is that he has been awarded two punishments for the same offence, as he has been debarred from appearing in any examination conducted by DSSSB and after that he was also terminated from his services. The applicant Sh. Deepak has requested to present his case through personal hearing and be reinstated to existing employment/job and provide him all the consequential benefits.
- 4. DSSSB issued advertisement No. 3/13 dt. 12.09.2013 for post code-40/13, Grade-II(DASS)/ASO, Services Department, GNCT of Delhi. On the basis of Tier-II exam held on 25.11.2018, result was declared vide result Notice No. 772 dated 19.03.2019. Sh. Deepak was selected for this post code and joined in Department of Food Supplies & Consumer Affairs on 15.07.2019 as Grade-II(DASS)/FSI.
- 5. DSSSB has issued advertisement for the post code 16/17 & 01/18, Teacher Primary in MCD in the year 2018 vide advertisement no. 01/2018. <u>An unknown person on behalf of Sh. Deepak appeared in the exam on 30.09.2018.</u> Result for the said post was declared vide Result Notice No. 773 dated 28.03.2019. On the basis of marks secured in written exam Sh. Deepak Roll No. was under provisionally selected list.
- 6. On scrutiny of documents (2nd Page of Admit Card) while forwarding of e-dossier to MCD, it has been found that an unknown person on behalf of Sh. Deepak appeared in the exam for the post code 16/17 & 01/18, Teacher Primary in MCD conducted on 30.09.2018. Therefore, in view the above the candidature of Sh. Deepak was cancelled vide Notice No. 1022 dated 07.02.2020. Subsequently vide order dated 17.03.2020 Sh. Deepak was debarred from any examination conducted/to be conducted by DSSSB for lifetime w.e.f. 30.09.2018. In the order the candidature of Sh. Deepak was deemed cancelled if he had appeared in any exam conducted by DSSSB prior to 30.09.2018.
- 7. On the basis of action taken by DSSSB the services of Sh. Deepak was terminated by Department of Food Supplies & Consumer Affairs Department order dated 30.09.2020.



8. The OA No. 575/2021 filed by Sh. Deepak has been dismissed by Hon'ble CAT vide order dated 16.03.2021 as he has sought permission to withdraw the OA with liberty to make a representation.

9. That on perusal of representation it reveals that the applicant has no grievance regarding debarment order issued by DSSSB, hence no action is required on the part of DSSSB. Accordingly the representation dated 23.06.2021 of applicant is hereby disposed off.

10. These issues with the approval of the Competent Authority and in compliance of the direction of Hon'ble CAT.
