TGT (Natural Science), POST CODE-135/17 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total 222 vacancies (UR-143, OBC-33, SC-31 & ST-15 including PH/OH-03 & PH/VH-03) for the post of TGT (Natural Science) Male under Post code-135/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on 29.09.2018.

- 2. On the basis of online examination of Tier-1 held on 29.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT(Natural Science), Post Code-135/17 in Directorate of Education, a total of 204 (UR-136, OBC-22, SC-29, ST-14, PH/OH-03) were provisionally nominated vide Result Notice No.455 dated 28/05/2019 and the candidature of 13 candidates (04- UR,06-OBC,02-SC and ST-01) were kept pending for want of clarification/documents. Out of these 13 pending candidates, 09 candidates were nominated vide supplementary result Notice No.533 dated 09.10.19 and 04 candidates (UR-03 and SC-01) were given second and final opportunity to upload their deficient documents in their e-dossiers. Further, the candidature of one SC category candidate was also revived and first opportunity was also given to him to upload deficient document. These **04 pending candidates** (UR-03 and SC-01) to whom second opportunity was given were recalled w.e.f. 14.10.2019 to 20.10.2019 but one candidate having Roll No.110913501126, to whom first opportunity was given, could not be recalled due to technical problem. These 04 pending candidates (UR-03 and SC-01) who were recalled second time, failed to upload the requisite document in stipulated time and their candidature is being rejected. Further, user department vide letter dated 27/12/2019 has returned 09 dossiers (UR-07, SC-01 & ST-01) after cancellation of candidature with the request to provide substitute from waiting panel thereby creating a total 13 vacancies (UR-10, SC-02 & ST-01) in the post code 135/17.
- 3. Further, as per direction of Hon'ble High Court vide order dated 18.11.19 in WP(C) No.12044/2019, one post need to be kept vacant under UR category. Also, there was no vacant post available under SC category but one candidate is already pending under SC category, therefore one post need to be kept vacant for him. Thus, 09 candidates under UR category, 01 candidate under SC category and 01 candidate under ST category immediately available below last nominated candidate is being nominated as well as in compliance of Hon'ble CAT's order dated 04.12.2019 in O.A. No. 3405/2019, Jitender Vs GNCT of Delhi, one candidate is also being nominated under PH(OH) category. However, as there is no vacant post is available under PH/OH category, consequent upon nomination of said candidate

the last candidate under PH/OH category nominated vide Result Notice No.455 dated 28/05/2019 is being withdrawn and kept in waiting panel.

4. Accordingly, in continuation to Result Notice No.455 dated 28.05.2019, and supplementary Result Notice No.533 dated 09.10.2019 the candidates detailed below are also provisionally selected on the basis of online examination of Tier-I held on 29.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of TGT(Natural Science) Post Code-135/17.

5. Withdrawl of Nomination of Roll No. 110613500461 from Result Notice No. 455 dated 28.05.2019

Consequent upon nomination of above said PH(OH) candidate in para 4(iv) having Roll No.120113502185, the nomination of Sh. Rahul Shrotriya (Roll No.110613500461) which was earlier mentioned in Result Notice No 455 dated 28.05.2019 at S.N.02 in PH-OH Category, is hereby withdrawn and kept in waiting panel. User Department is requested to convey the decision to the candidate and return his dossier to DSSSB.

6. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of

advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- 7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny / correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008, O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

- 10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 11. The user department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 12. The result process for the above post code stands closed in all respect except 02 vacancies i.e. 01 under UR category due to pending court case and 01 under SC category due to technical reasons which have been kept pending for want of deficient document in the e-dossier as referred at para-13 in Supplementary Result Notice No. 533 dated 09.10.2019..
- **13.** Further, as per result notice no. 455 dated 28/05/2019 wait list panel for the post code 135/17 shall be valid for a period of one year, i.e. upto 27.05.2020.
- **14.** The category-wise marks obtained by the last provisionally nominated candidate are as under:-
