SPEAKING ORDER

WHEREAS, the Hon'ble High Court vide order dated 20/03/2026 in WP (c) No. 10565/2019 (GNCTD & Ors. Vs. Urmila) that "the Tribunal by way of the IO-5, issued an interim direction for consideration of the candidature of the private party. The Tribunal noted that the advertisement, at its inception, contemplated submission of hard copies of documents and did not expressly stipulate the requirement of uploading the same through an e-dossier mechanism.

53. The Government in its counter affidavit filed before the Tribunal stated that that shortlisted candidates were intimated through SMS at regular intervals. However, the report subsequently placed before this Court merely states that no failure of delivery of email was recorded during the prescribed period in respect of the private party's email ID. The undertaking does not disclose the precise date or time at which the alleged communication was effected, nor does it establish that such intimation was made in a manner affording the private party a fair and effective opportunity within the prescribed window.

54. The absence of specific particulars regarding the timing of communication, coupled with the initial ambiguity in the advertisement regarding the mode of submission, lends credence to the Tribunal's prima facie view that the private party ought not to be W.P.(C) 938/2026 & connected matters Page 25 of 33 non-suited at that stage. The material placed before this Court does not dislodge the basis of the interim protection granted. Accordingly, the present petition is dismissed."

WHAREAS, the Board advertised vide No. 04/2017 dated 20/12/2017 the vacancies for the post of PGT (Sociology) Female under Post Code 130/17 and one tier written examination was conducted on 19/08/2018. In all 41 vacancies were notified, against which 95 candidates were shortlisted. Thereafter, a general notice was published on the website of the Board informing them that marks list has been uploaded on the website and the shortlisted candidates were asked to download the check list and duly filed up e-dossier be uploaded w.e.f. 15/01/2019 to 24/01/2019. Besides this, the File No. DSSSB-LCOL1/2/2026-Admin-DELHI SUBORDINATE SERVICES SELECTION BOARD (DSSSB) (Computer No. 324413) shortlisted candidates were also

invariably sent SMS through registered Mobile Phone Number. Urmila was given ample time yet she failed to upload the documents on the e-dossier portal. Since the applicant failed to upload the e-dossier during the above mentioned period, Urmila candidature could not be considered.

WHEREAS, out of a total of 95 candidates shortlisted, 89 candidates have uploaded their documents in response to the said notice and 06 candidates, including Ms. Urmila have failed to upload their documents.

WHEREAS, the applicant, Urmila (D.O.B. : 08/01/1987), Roll No. 2480003876, applied under the SC category and secured 139.75 marks out of 300 marks in the written Examination. The Cut Off marks is 140.25 in this category.

WHEREAS, in view of the above, the applicant is not falls in consideration zone as Ms. Urmila secured marks (139.75) which is below cut-off marks (140.25), so she is not qualifying for the Post of PGT (Sociology) Female and therefore, as per direction of the Hon'ble High Court the candidatures of Urmila cannot be considered for nomination against Post Code 130/17.

NOW THEREFORE, this speaking order is issued with the approval of the Competent Authority and in compliance with the directions of the hon'ble High Court of Delhi vide order dated 20/03/2026 passed in WP (c) No. 10565/2019 and connected matters.

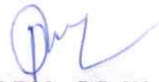
