SUPPLEMENTARY RESULT NOTICE NO. 601

SUPERVISOR, GR.II (FEMALE) IN DEPTT. OF WOMEN & CHILD DEVELOPMENT

The DSSSB vide its advertisement No.02/2014 dated 12/12/2014 had advertised total 290 vacancies [UR-145, OBC-79, SC-44 & ST-22 including PH/OH-03. PH/VH-03 & PH/HH-03] for the post of Supervisor, Gr.II(Female) under Post code-212/14 in Department of Women & Child Development with closing date as 25.01.2015. Out of 290 vacancies, 25% are reserved for Anganwari workers. Thus, the total vacancies available for direct recruitment was (UR-109, OBC-59, SC-33 & ST-16 including PH/OH-02, PH/VH-02 and PH/HH-02) and the reserved vacancies for Anganwari workers was (UR-36, OBC-20, SC-11, ST-06 including PH/OH-01, PH/VH-01 & PH/HH-01) Tier-I examination in offline examination mode was conducted on 05.03.2017.

- On the basis of offline examination of Tier-1 held on 05.03.2017 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.02/2014 and RRs for the post of Supervisor, Gr.II(Female), Post Code-212/14 in Department of Women & Child Development, a total of 161 (UR-93, OBC-38, SC-23 and ST-07 including PH/OH-01) candidates were provisionally nominated for the post of Supervisor, Gr.II (Female) under direct recruitment quota and SC-01 under Anganwari worker quota vide Result Notice No.149 dated 06.06.2017 and the candidature of 48 candidates were kept pending for clarification and Court case candidates and the candidates whose candidature were kept pending have been directed to upload the requisite documents. Further, 01 candidate was provisionally nominated vide Result Notice No.223 dated 25.01.2018. Thereafter, a total of 06 (OBC-05, SC-01) were provisionally nominated vide Result Notice No. 234 dated 22/03/2018. Further, 13 candidates (UR-05, OBC-06 and SC-02) were nominated against the dossiers of 14 candidates returned by the user department against direct recruitment quota and 01 SC candidate under Anganwari worker quota were provisionally nominated vide Result Notice No.259 dated 22/06/2018. Thereafter, 25 candidates vide supplementary result notice no., 494 dated 16.08.2019 were nominated for the post of Supervisor, Gr. II (Female), Post Code-212/14. The candidature of 20 candidates have been kept pending i.e. 17 for court case candidates, 01 for want of deficient documents & 02 for PH candidates. Out of these 17 pending court case candidates, candidature of 01 candidate in O.A. No. 3187/2017 has been rejected vide rejection notice no. 547 dated 26.11.2019.
- 3. Further, out of 16 pending court case, one candidate, Ms. Himanshi Singh (Roll No.12205334) had filed O.A. No. 1835/2018 in Hon'ble CAT. At the time of declaration of result notice no. 149 dated 06.06.2017, she was not in selection zone, however, as per direction of Hon'ble CAT, one vacancy had been kept vacant for her. The merit has come down as mentioned in supplementary result notice no. 494 dated 16.08.2019 and she is eligible for selection on her own merits. However, she was not nominated as the matter was subjudice. Now, the Hon'ble CAT vide order dated 13.12.2019 has disposed off the O.A. No. 1835/2018 in the matter of Himanshi Singh Vs. Govt. of NCT of Delhi & Ors. directing the Board to take consequential steps.

4. Now, therefore, in continuation to Result Notice No.149 dated 06/06/2017; Result Notice No.223 dated 25/01/2018; Result Notice No.234 dated 22/03/2018, Result Notice No.259 dated 22/06/2018 & Supplementary Result Notice No.494 dated 16.08.2019, the following candidate, as per details given below, is also provisionally nominated, on the basis of Tier-I examination in offline mode held on **05.03.2017** and as per documents uploaded in support of educational qualification, age etc., in accordance with advertisement No.02/2014 and RRs for the post of Supervisor, Gr.II (Female).

- 5. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of her identity with reference to her photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- Further, if applicable, User Department shall verify the genuineness of the Caste Certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and edossier vis-à-vis the original documents. The User department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User department is also requested to rectify/correct, in case any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- It is stated that the User Department shall verify the genuineness of the caste 7. certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed specified various certificate (Delhi) as OBC entitlement for Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 11. The recruitment process for the post of Supervisor, Gr.II (Female) stands closed in all respect except 18 [15 vacancies (UR-04, OBC—05, SC-06) for court case candidates and 03 vacancies for want of deficient documents/requisite documents in the e-dossier.
- 12. Further, wait list/panel for the post code-212/14 stands expired on 05.06.2018, i.e. after one year from the date of declaration of result on 06/06/2017.
- 13. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 14. The category-wise marks scored by the last candidate provisionally nominated is given in tabular form as under:-
