RESULT NOTICE NO-471 WARDER (MALE) IN DELHI PRISONS DEPARTMENT UNDER POST CODE 37/2013

The DSSSB vide its advertisement No 02/2013 with closing date 02/08/2013, had advertised 528 vacancies (UR-268, OBC-142, SC-79, ST-39 out of which 53 vacancies were reserved for Ex-servicemen) for the post of Warder Warder (Male) in Delhi Prisons Department in the pay scale of Rs. 5200-20200 having Grade Pay of 1900/- (Non- Gazetted-Non Ministerial). The Board had conducted the written examination for post of Warder (Male) under Post code 37/13 on 02.03.2014. After conducting the Physical Endurance Test (PET-I) in respect to shortlisted candidates from 16.03.2015 to 22.03.2015, the final result was declared vide Result Notice No. 357 dated 29.12.2015; and subsequent Result Notice No. 381 dated 07.03.2016 and Result Notice No 382 dated 13.04.2016, whereby Board had nominated 220 candidates under post code 37/13) for the post of Warder (Male).

Later, on the request of the user department for nominating the candidates from the unfilled vacancies, the cutoff marks for short listing the candidates for appearing in Physical Endurance Test (PET-II) were reduced and vide Notice No 395 dated 15.06.2016 and subsequent Notice No 409 dated 11.07.2016 and Notice No. 468 dated 31.01.2017. The Physical Endurance Test for the candidates shortlisted on 15.06.2016 was conducted from 01.07.2016 to 09.07.2016. The Physical Endurance Test in respect of candidates shortlisted on 11.07.2016 and 31.01.2016 is to be conducted.

On the basis of the merit list of written examination and consequent upon qualifying the petal and after preliminary scrutiny of eligibility for the post as per provisions of the statutory Recruitment Rules and the terms and conditions of the advertisement, the following candidates, are hereby

The selection of the above 65 Candidates shall be further subject to the thorough verification of the candidature of the candidates by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidates.

The User department shall also check the eligibility of the reservation benefit, if any, as per the reservation policy of the Government of NCT of Delhi. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness/ genuineness of the information/ documents as furnished in the application form vis-à-vis the original documents. The appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Further, the User Department shall arrange the checkup of selected candidates regarding any defect or deformity (including bow-legged, knock-



kneed, flat feet etc) which will render candidate ineligible for recruitment, as per RRs of the post before issuing them an offer of appointment for the post.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
