1. The DSSSB vide its advertisement No.05/24 had advertised **total – 04 vacancies (UR- 03 & OBC- 01)** for the post of **Assistant Director (Horticulture)** under **Post Code- 21/24** in **NDMC**, read with corrigendum dated **08.07.2025** regarding partial modification in exam scheme.
2. The written examination (online mode) was conducted on **17.04.2025**.
3. The marks obtained by **51 candidates** who have duly appeared in examination (online mode) held on **17.04.2025** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssonline.nic.in**
4. Based on the performance in the Tier-I written examination (online Mode), a total of **11 candidates** who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II examination, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Tier-II Examination does not entitle them any right over the post.
6. **Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidate, have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.**
7. Further, all the candidates who have scored marks equal to the cut off marks in each category have been shortlisted.
8. As per the Board Policy the minimum qualifying marks in one Tier written examination for UR & EWS Category Candidates is 40%, for OBC candidates is 35% and for SC, ST & PwBD candidates is 30%.
