CHAPTER 1

Highlights

1. Vacancies & Posts Notified

Three advertisements were published for inviting applications for 1,808 numbers of vacancies in respect of 32 different post codes for various departments of GNCT of Delhi/Autonomous Bodies/Local Bodies through Advertisement No. 01/2021 during the period under report. **(Chapter – 05)**

2. Examination/Skill Test/PE Test Conducted

Board conducted written examinations of 11108 numbers of candidates of 25 post codes during the year 2020-21. This includes T-2 examination of 12 post codes for 590 notified vacancies. Besides written exam, Physical Endurance Test (PET)/PSE for the posts of Prison Department, College of ART, NCC HG&CD and Higher Education were conducted, wherein 141 numbers of candidates were called. Similarly, skill test against 716 vacancies of Six departments covering 5774 number of shortlisted candidates was also conducted. **(Chapter – 06)**

3. Results Processed/Declared

Board declared examination results of 59 post codes for 4758 notified vacancies/unfilled vacancies during the year 2020-21. Besides, skill test results of Services Department, DPCC, H & FW, DSCSC, RSB, HGCD, DIP and DAMB having 1008 vacancies were also declared. **(Chapter – 07)**

4. Dossiers of Provisionally Selected Candidates Forwarded to User Departments

Board forwarded 5557 number of dossiers/e dossiers of provisionally selected candidates to user departments during the year 2020-21, which includes 2493

number of Group 'B' and 3064 number of Group 'C' provisionally selected candidates. **(Chapter – 08)**

5. Results Closed

Board has closed results of 57 post codes for 4257 numbers of notified vacancies during the year 2020- 21, including 02 post codes for 39 notified vacancies results for which were declared prior to 2020-21.

The closure of above results led to return of 808 unfilled vacancies to the user departments for inclusion in subsequent requisitions. **(Chapter – 09)**

6. Major Initiatives:

Board undertakes and complete implementation the Computer base Examination System (CBES) complete from Paper Based Examination (PBE), E Dossiers module in OARS system for calling of dossiers, Training of exam functionaries and Frisking/Dress code of the candidates. **(Chapter 10)**

CHAPTER 2

History of Recruitment Process in NCT of Delhi

As per Article 320 of the Constitution of India, the examinations for recruitment to all posts and services of the Central Government are required to be conducted by the UPSC. However, the estimates Committee of Parliament in its 47th Report (1967-68) recommended setting up of a Service Selection Commission for taking over from the UPSC, examinations for recruitment to lower category of Class III posts. The Administrative Reforms Commission also in their Report on Personnel Administration made similar recommendations. Accordingly, it was decided by the Government of India to set up Subordinate Service Commission to conduct recruitment examinations to Class III categories, which constituted the bulk of the staff of the government at the Centre and in the States. After a careful consideration of the recommendations, the Government of India constituted the Subordinate Services Commission vide Department of Personnel and Administrative Reforms' Resolution No.46/1/(S)/74-Estt. 'B' dated the 4th November, 1975. This Commission was subsequently re-christened as Staff Selection Commission (SSC) in September, 1977. It was empowered to make recruitment to Group 'B' and Group 'C' posts in various Ministries/Departments of the Government of India and its Subordinate/ attached Offices. However, the work relating to recruitment to Group A and Group B Gazetted posts remained with the UPSC.

Further, the work relating to recruitment of DASS and Stenographer cadre's posts for Delhi Administration (now GNCT of Delhi) was assigned to SSC. The recruitment to Group C ex-cadre posts and Group D posts remained with the respective Heads of Departments of GNCT of Delhi. The major recruitment of ex-cadre posts were done by Education, Health & Family Welfare Departments. These departments had their own full fledged examination branches and Technical Recruitment Cells for the recruitment of teaching and medical posts. Delhi Police, MCD, NDMC, etc. had their own mechanism for recruitment and GNCT of Delhi had no role in it. Similarly, Autonomous Institutions,

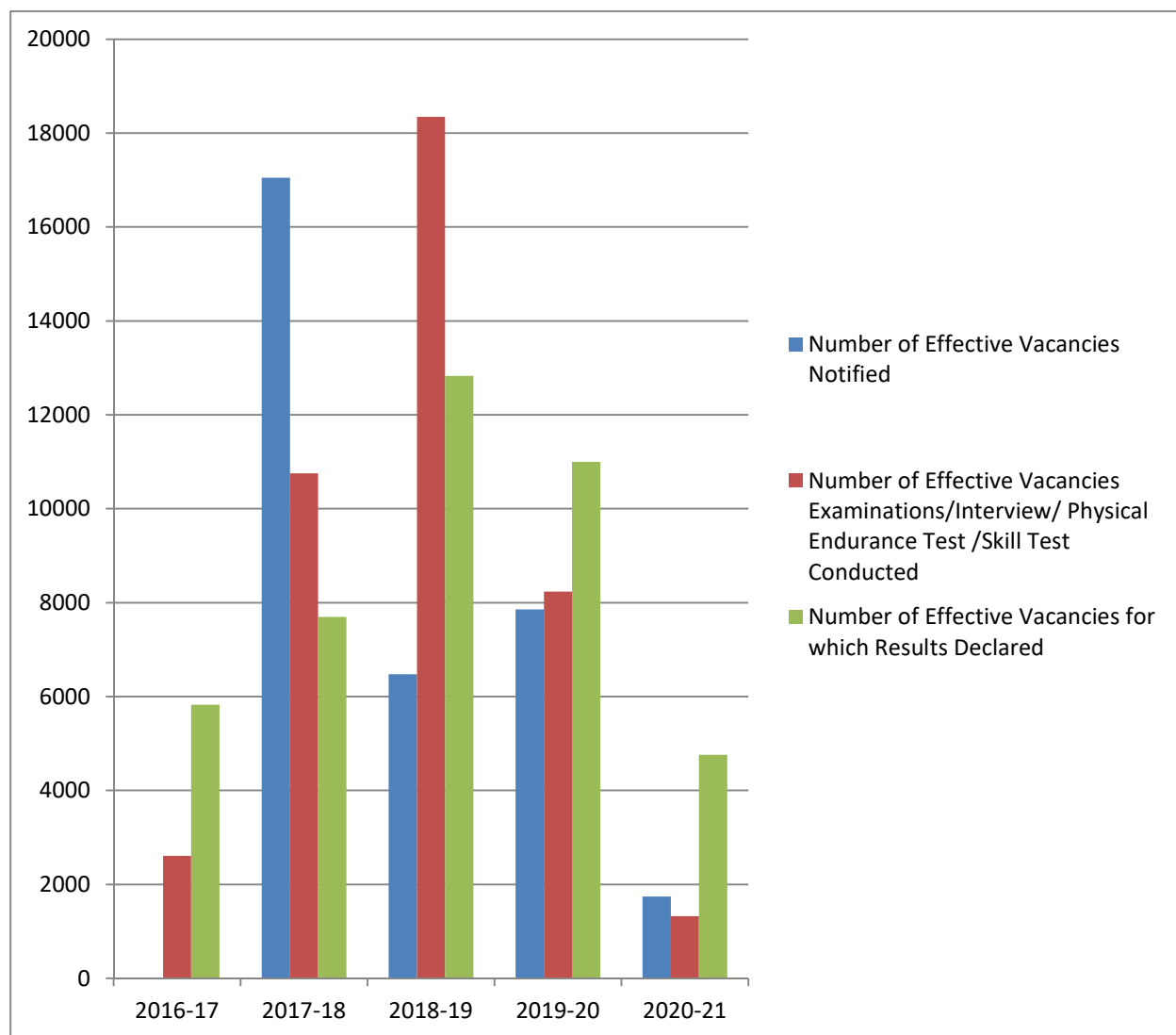
Undertakings, Boards and Bodies like DFC, DSCSC etc. of GNCT of Delhi were adopting their own procedures in the recruitment process.

But after enactment of Government of NCT Act, 1991 and to do away with the multiplicity of authorities in the recruitment process within the GNCT of Delhi, MCD, NDMC and its subordinate/ attached Offices, Autonomous Institutions, Undertakings, Boards etc. GNCT of Delhi had decided to set up an independent Delhi Subordinate Services Selection Board (DSSSB) for ensuring a free and fair recruitment process with transparency and accountability, for all these organizations, as an attached office to Services Department of GNCT of Delhi in 1997, vide Resolution No. F 3(7)93-5, III dated 04.10.1996. However, the work relating to recruitment to Group A and Group B Gazetted posts remained with the UPSC. **(Resolution 01)**

CHAPTER 3

Mandate of the Board

The Government of National Capital Territory of Delhi (hereinafter called the GNCT of Delhi) set up the Delhi Subordinate Services Selection Board (hereinafter called “Board”) vide Resolution dated 4th October, 1996. It has been set up primarily to take over the work relating to selection/recruitment of Grade ‘B’ (Non-Gazetted) and Grade ‘C’ posts, both technical and non-technical, of different Departments of GNCT of Delhi (including Delhi Police) and its Local Bodies, Autonomous Bodies, Undertakings etc. The Board is an attached Office of the Services Department, GNCT of Delhi. Prior to this the recruitment of Grade II & IV posts of DASS cadre (Assistants/Inspectors and LDCs) and Stenographers etc. were under taken by the Staff Selection Commission of Government of India and those of ex-cadre posts by the respective Departments/organizations. The Board commenced its functioning in July, 1997. **(Resolution 01)**

The GNCT of Delhi restructured the Board vide Resolution dated 12th May 2008. The Board is headed by a Chairman and comprises of two Members, Controller of Examination and a Secretary along with other Supporting Staff. Initially the Board consisted of one Member but the number was raised to two under the restructured set up. Likewise the staff strength of the Board was enhanced. **(Resolution 02)**

Subsequently, vide Resolution dated 13th October 2015, clause 3 B (iii) of Resolution dated 12th May 2008 substituted and the Chairman of the Board was entrusted to exercise Administrative & Financial powers of Principal Secretaries / Secretaries to the Government, on behalf of the Board. **(Resolution 03)**

The Board (DSSSB) vide notice 02.06.2017 and 19.07.2017 has decided to dispense with the interview from the selection process in respect of all posts. As such, selection process in respect of posts having three tier examination scheme, whether already advertised with such scheme and/or posts where selection process is in mid-way, shall be converted into two-tier examination scheme with immediate effect and the final selection shall be made based on merit in Tier-II examination. Further, all posts for which screening test has been conducted and it was to be followed by interview, the screening test shall be disregarded/scrapped and selection shall be made as per the general scheme of exam prescribed for that post if the number of candidates is more than 500. **(Resolution 04 & 05).**

CHAPTER 4

Mission/Vision

The Board is committed to develop selection and recruitment procedures that conform to the global standards in testing and promises selection by fair and transparent manner for the user Departments. The Board continuously endeavors to ensure that the recruitment is done purely on merits in an impartial and objective manner.

In order to achieve the mission the board broadly undertaking the following major activities:

- (i) On receipt of requisitions from the user Departments/organisations for the recruitment of various posts, the Board examines the proposals, compiles and collates the data/information for initiating the process of selection.
- (ii) A consolidated Advertisement of various posts for which recruitment is to be done is prepared and published in leading Newspapers, Employment News and web site of Board for inviting applications from eligible candidates.
- (iii) Online Applications are received from the applicants through the 'Online Application Registration System' (OARS) along with the requisite fee, wherever applicable.
- (iv) A date of conducting of examination for each advertised post is announced.
- (v) The examination centers are finalized and necessary arrangements made for the smooth conduct of examinations in a fair and transparent manner.
- (vi) Written Examinations are conducted on the scheduled date as per the examination scheme and policy of the Board for fair selection.

- (vii) The draft answer key of objective questions is published inviting objections in e-challenge module, there after answer key is finalized.
- (viii) Evaluation done based upon finalized answer key and marks uploaded on the online portal, which can be seen by the candidate through their login account. The shortlisted candidates are then asked to upload the requisite documents on e dossier module.
- (ix) After examination of documents uploaded by the shortlisted candidates, the final result of provisionally selected candidates is published on the website of the Board.
- (x) Lists of provisionally selected candidates along with their dossiers/ e dossiers are sent to the concerned user Department(s)/organization(s) for further processing including thoroughly examination of eligibility of candidates, issue of offer of appointment, conducting of medical examination, police verification etc.
- (xi) SMS and e mails are sent to each provisionally selected candidate to inform that their e dossiers have been sent to user department and they may contact to the user department for further necessary action.

CHAPTER 5

Posts Advertised

Three advertisements were published for inviting applications for 1,808 numbers of vacancies in respect of 32 different post codes for various departments of GNCT of Delhi/Autonomous Bodies/Local Bodies were advertised through Advertisement No. 01/2021 during the period under report. **(Appendix – 10)**

However, on withdrawal of certain requisitions after publication of advertisement, 67 notified vacancies of DJB and DSCSC, against post codes 15/21 and 30/21 given in advertisements No 01/21 had been withdrawn/cancelled from the advertisement on the request of user departments. Further, 01 number of vacancies of DJB has been added against post code 16/21 notified in advertisement no. 01/21 and 02 numbers of vacancies of DJB have been reduced / decreased against post code 14/21 notified in advertisement no. 01/21 respectively.

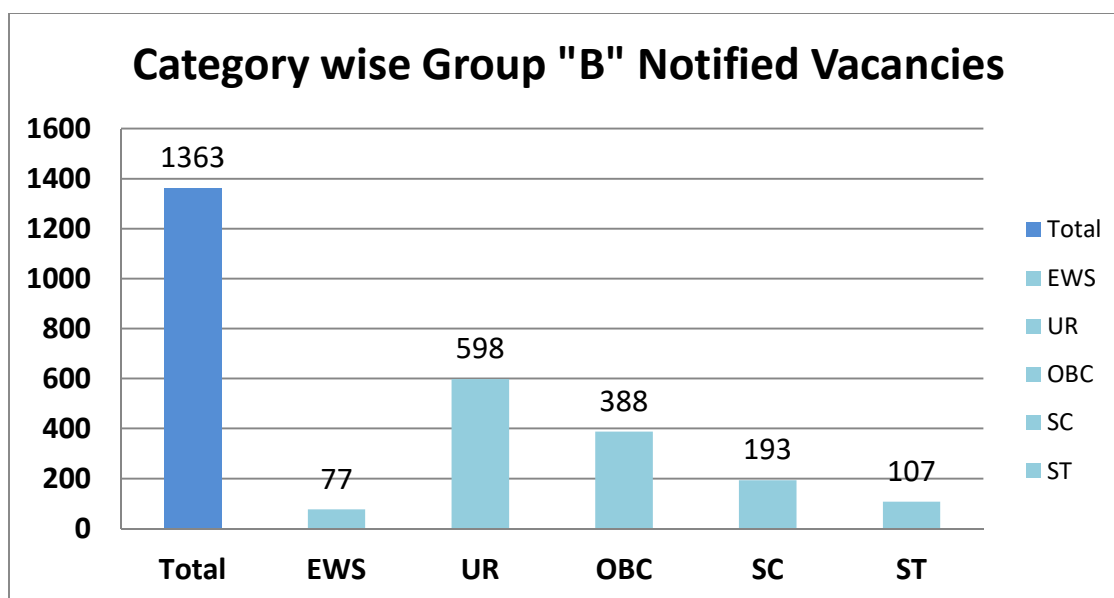
Effectively, in the year 2020-21 applications were invited for 30 posts code for 1,740 vacancies.

(i) Group 'B' Posts

Board notified 1,363 number of vacancies for 08 group 'B' posts for 04 users departments {Delhi Jal Board, DUSIB, DSW and MCD}. **(Table 5.1)**

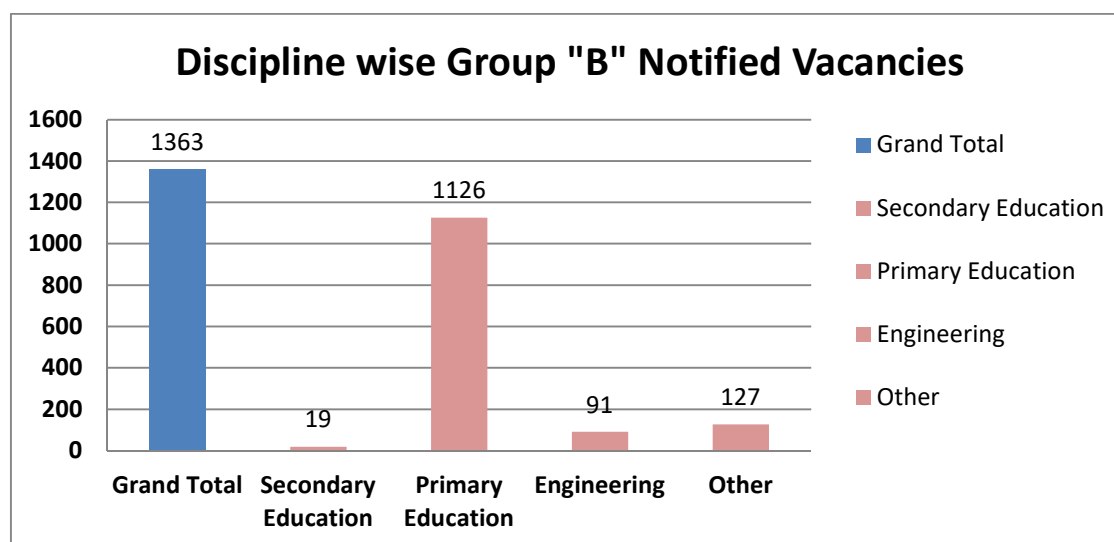
- Out of 1,363 numbers of notified vacancies 77, 598, 388, 193 and 107 identify for EWS, UR, OBC, SC and ST categories, respectively. Further, these EWS; UR, OBC, SC and ST categories identify vacancies consist 58 numbers of notified vacancies reserved for PWD. **(Table 5.1)**

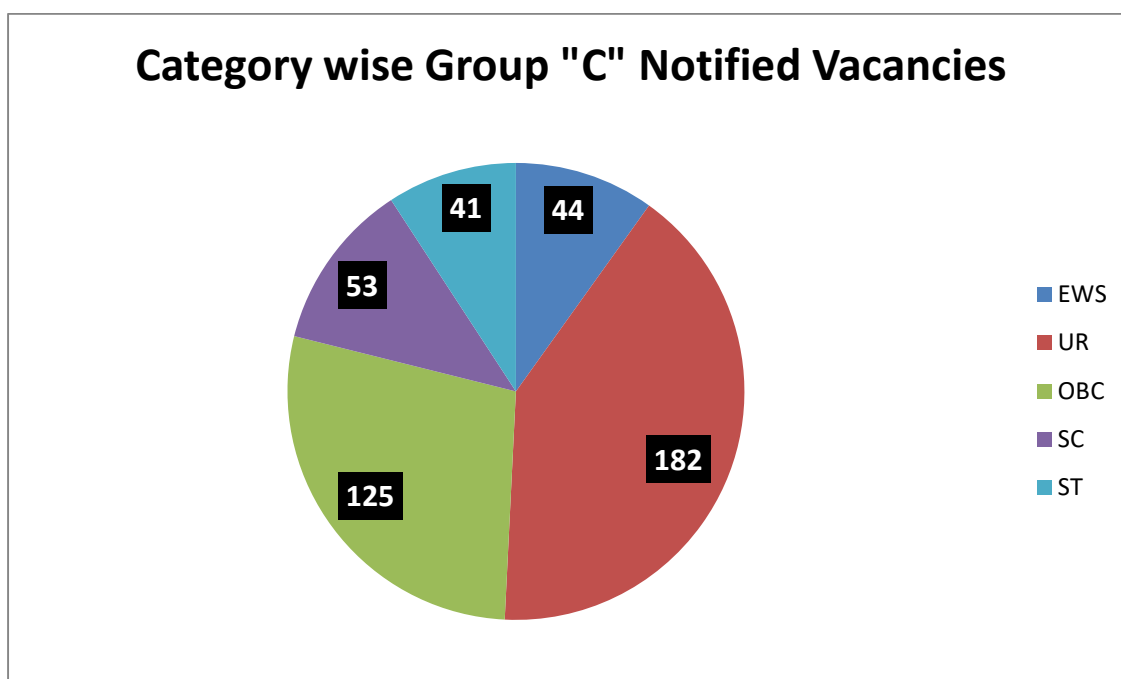


(ii) **Group 'C' Posts**

Board notified 445 number of vacancies for 24 group 'C' posts for 09 users departments like DTTE, Dte. of Ayush, DSIIDC, NDMC, Forensic Science Laboratory, DAMB, DTC, Delhi Jal Board, DSCSC etc. **(Table 5.3)**

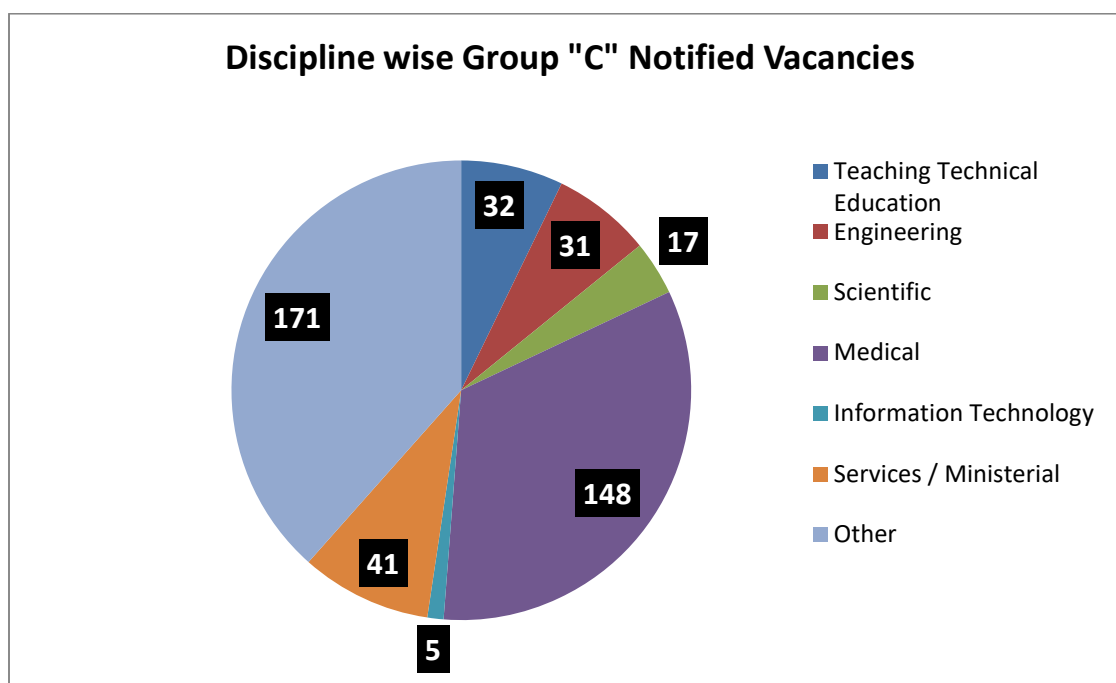
- Out of above, 445 numbers of notified vacancies 44, 182, 125, 53 and 41 identify for EWS, UR, OBC, SC and ST categories, respectively. Further, these EWS, UR, OBC, SC and ST categories identify vacancies consist 26 and 02 numbers of notified vacancies reserved for PWD and Ex-SM respectively. **(Table 5.3).**

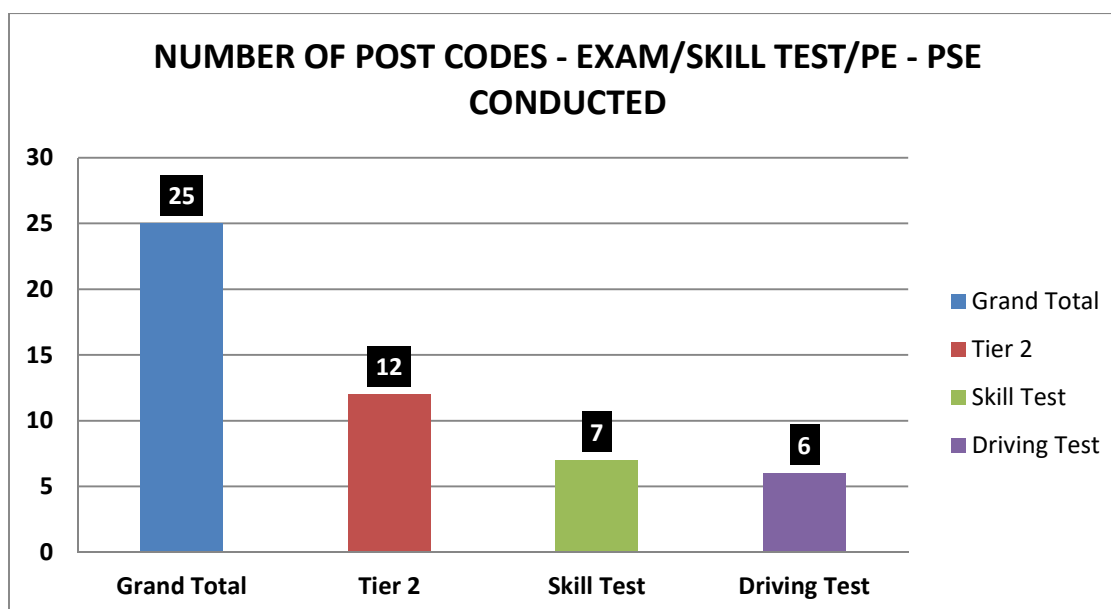
Examination / Skill Test / PE Test Conducted

Board conducted written examinations of more than 11108 numbers of candidates during the year 2020-21. This includes T-2 examination of 12 post codes for 590 notified vacancies. Besides written exam, skill test against 716 vacancies of six departments covering 5774 number of shortlisted candidates was also conducted. Similarly, Physical Endurance Test (PET)/PSE for the posts of Prison Department, Collage of Art, NCC, HG & CD and Higher Education were conducted, wherein 141 numbers of candidates were called. **(Appendix – 11)**

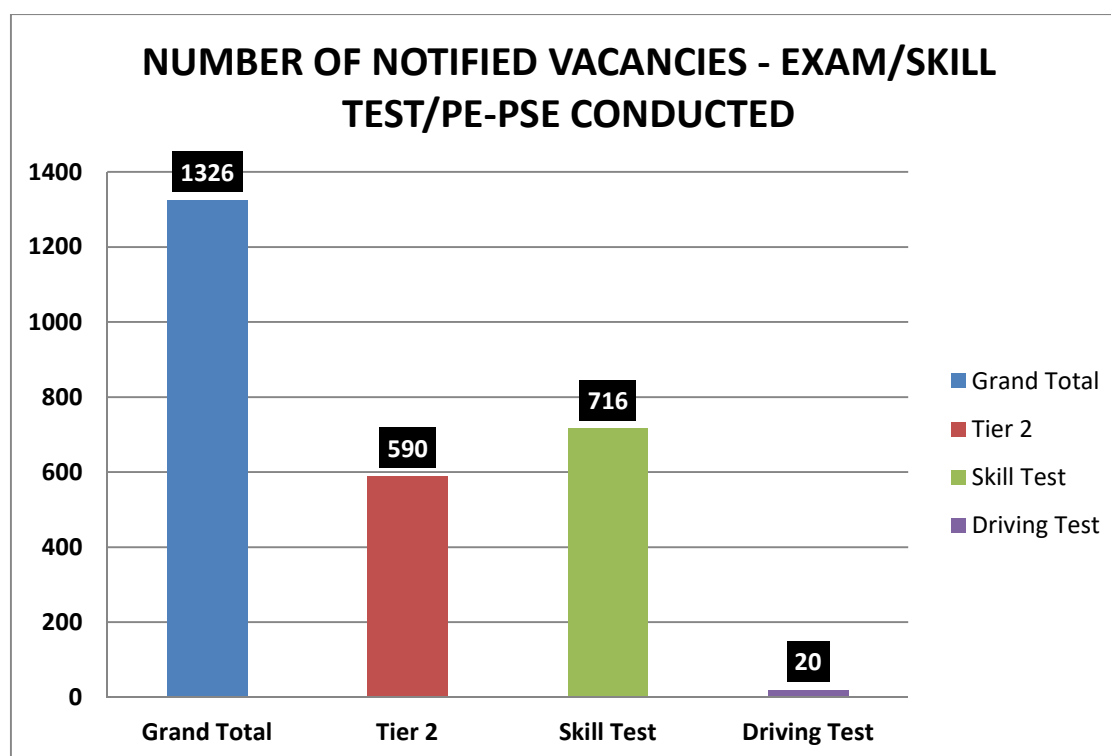

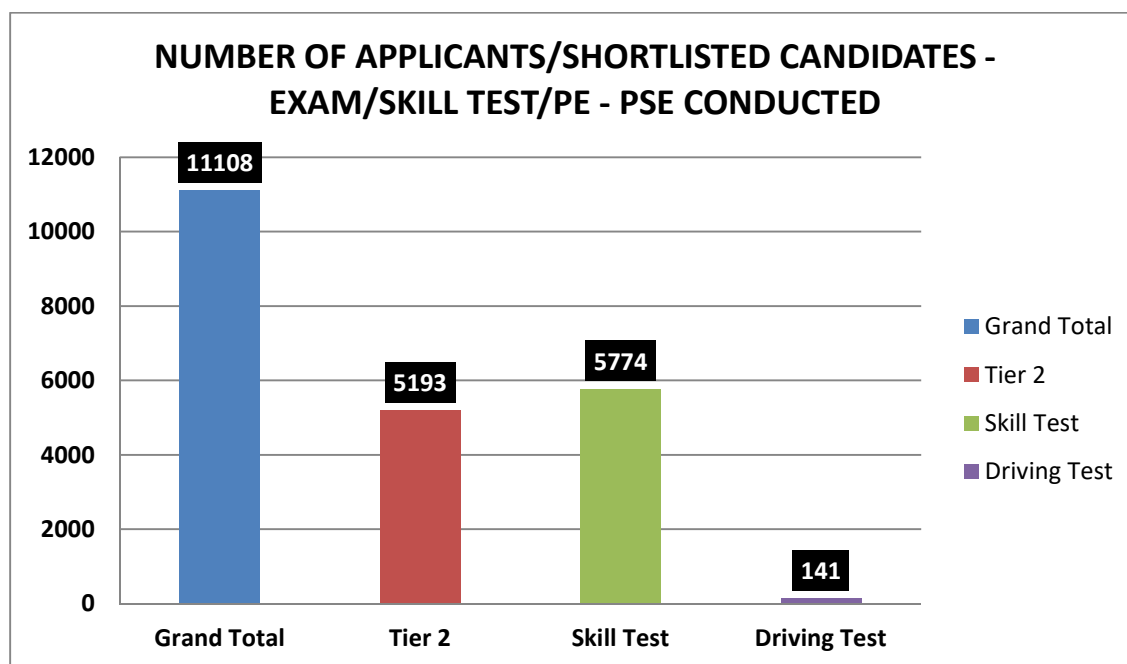

Analysis of Notified Vacancies and Applicants/Shortlisted Candidates Ratio

Board conducted Tier II examination of 12 post codes having 590 notified vacancies and 5,193 shortlisted candidates appeared during 2020-21 for provisionally selection under two tier examination schemes. The analysis of per notified vacancies and applicants/shortlisted candidates ratio of Tier II examinations shows that the post of Junior Engineer (Civil) – DAMB having highest number of 20 candidates and the post of Junior Engineer (Civil) – NDMC having lowest number of 5 Applicant / Candidates:-

In nutshell, most popular posts are LDC, Junior Clerk, Medical Record Clerk, Stenographer, Data Entry Operator, etc. and less attractive posts are in the disciplines of Science & Technology fields.

Board conducted PET/PSE of 06 post codes having 20 notified vacancies and 141 candidates/applicants during 2020-21 for short listing of candidates for holding Tier 1 examination under two tier examination schemes. The analysis of per notified vacancies and applicants/candidates ratio of PET/PSE shows that the post of Driver (Male) – Collage of Art having highest number of 24 and the post of Driver (Male) HMT & LMT – NCC and HG & CD having lowest number of 01 applicants/ candidates. **(Table 6.3)**

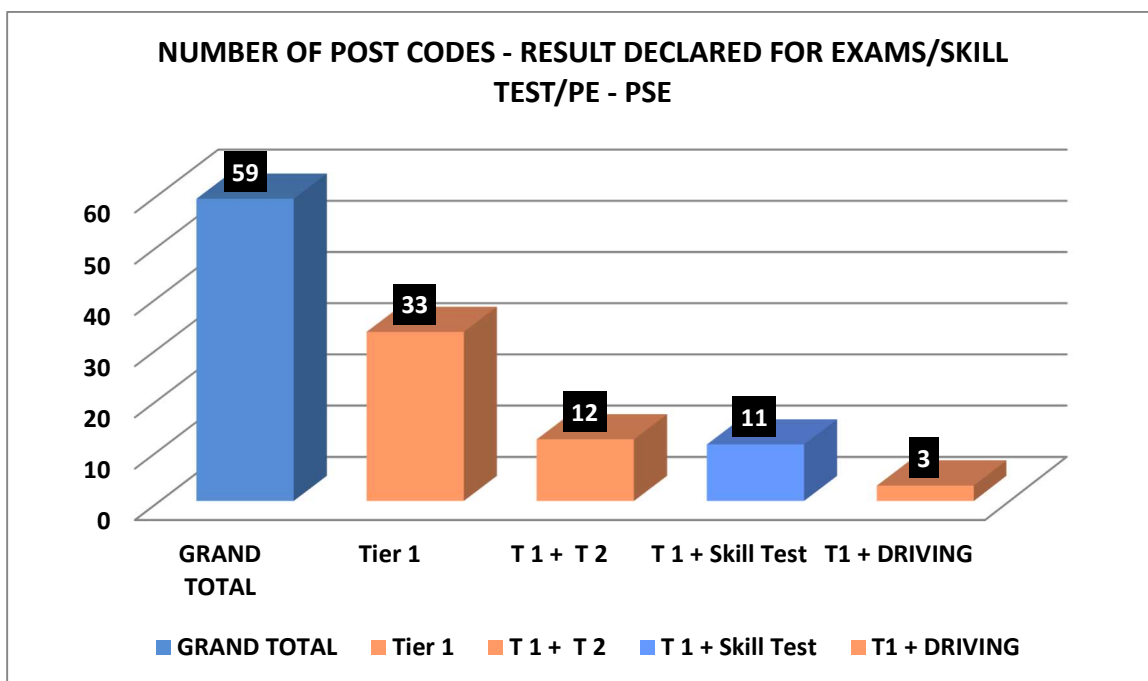
Main Results Processed / Declared

Board declared examination results of 59 post codes for 4758 notified vacancies/unfilled vacancies during the year 2020-21. Besides, results of Physical Endurance Test (PET) and Driving Test for the posts of Prison, Higher Education, College of Art and NCC were declared against 09 vacancies. Similarly, skill test results of H&FW, DSCSC, DPCC, RSB, DHGCD, Services Department and DAMB having 1008 vacancies were also declared. **(Appendix – 12).**

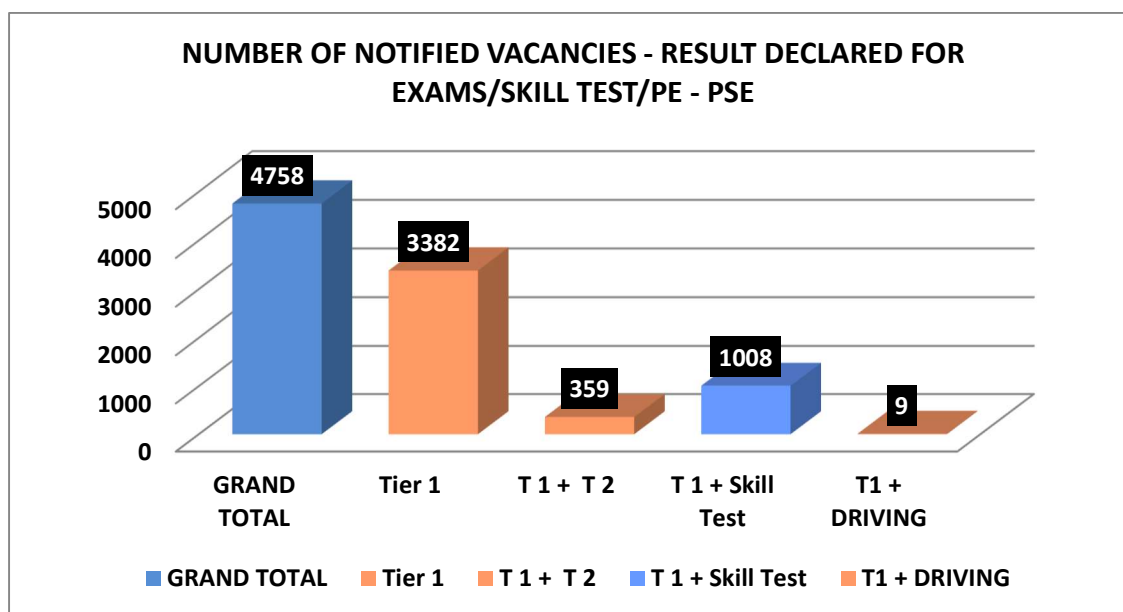

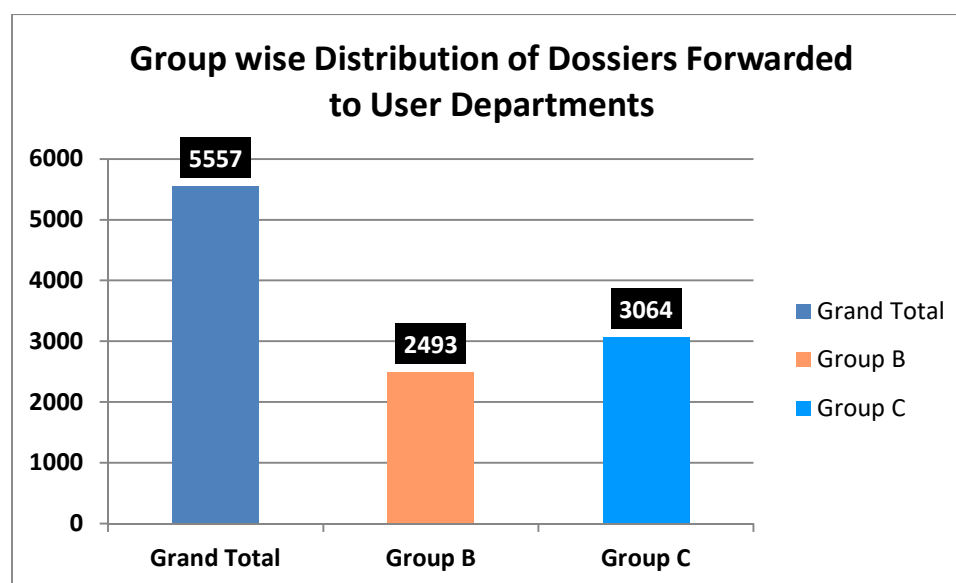


CHAPTER 8

Dossiers of Provisionally Selected Candidates Forwarded to User Departments

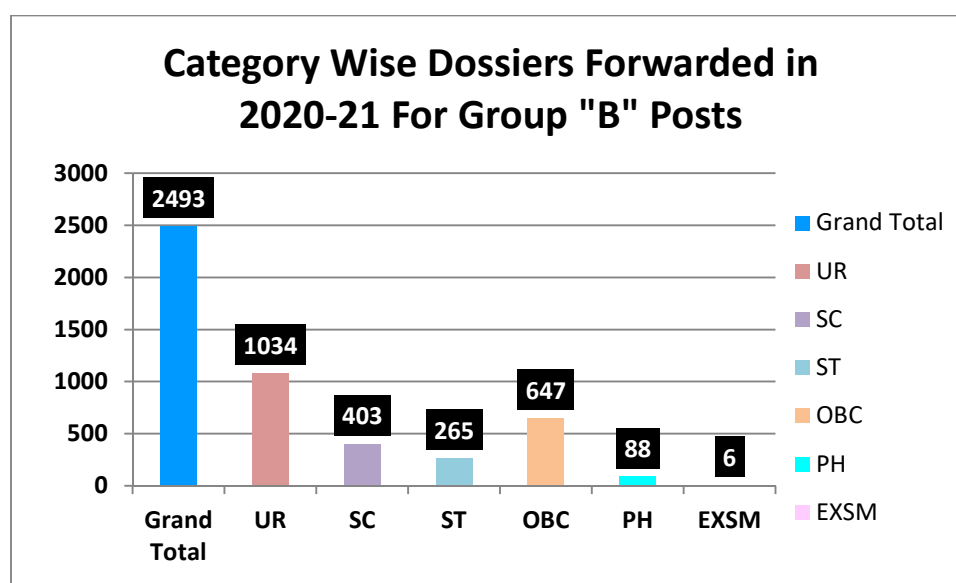

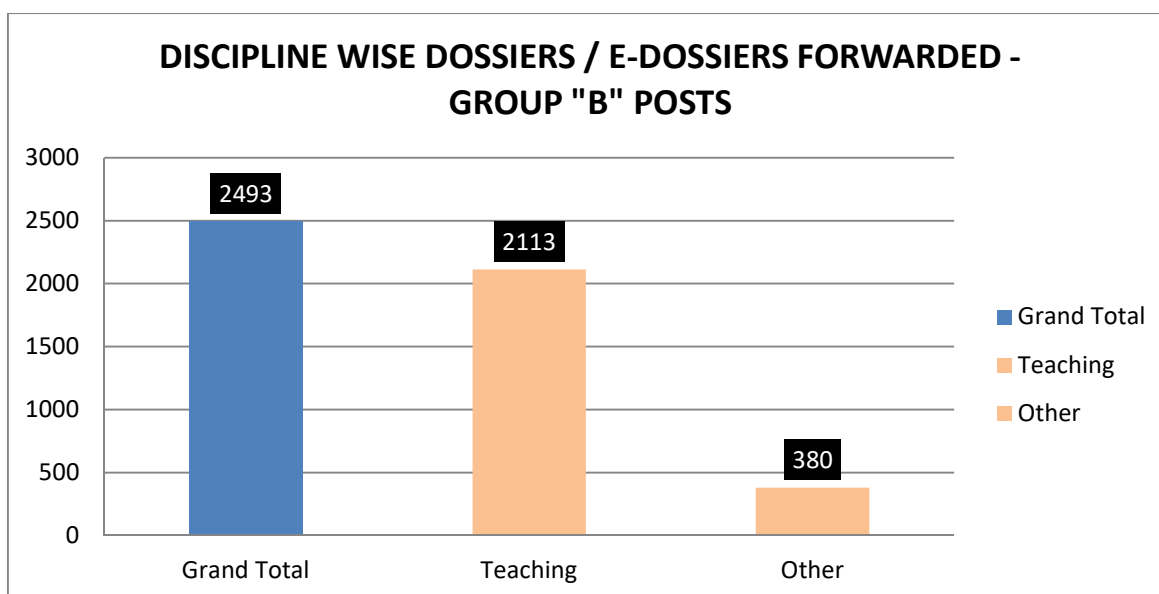

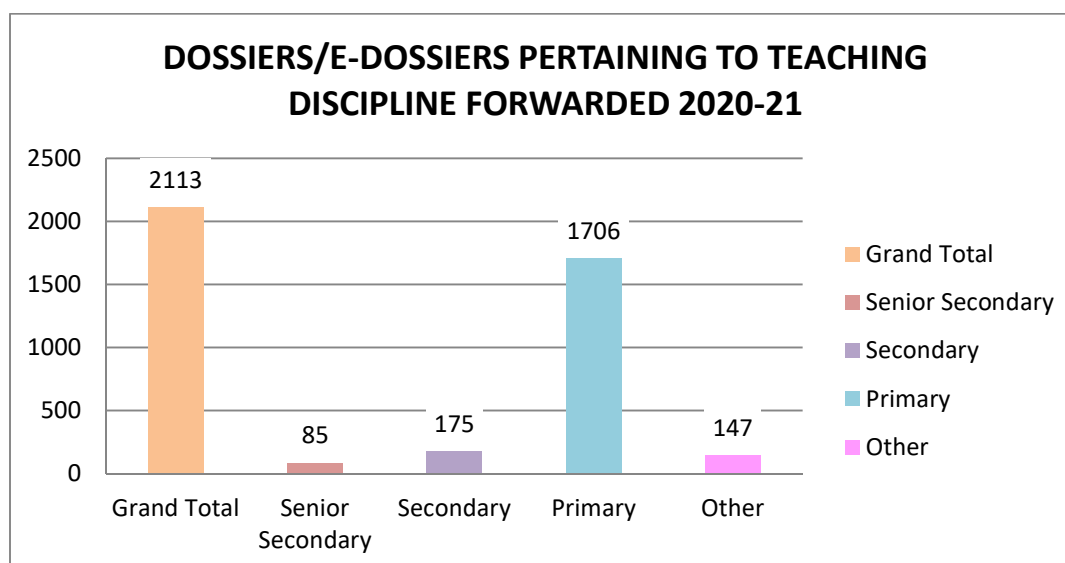

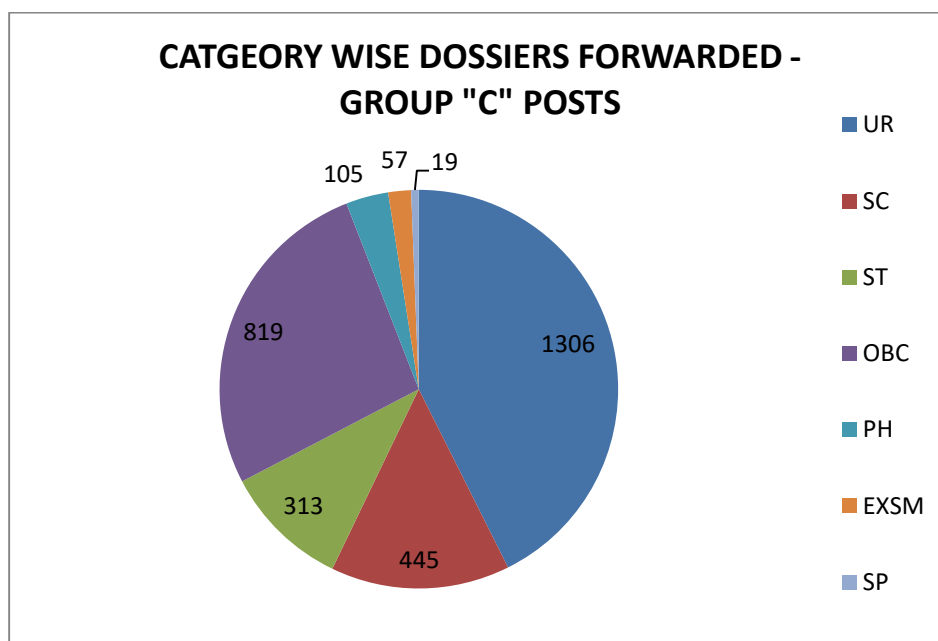

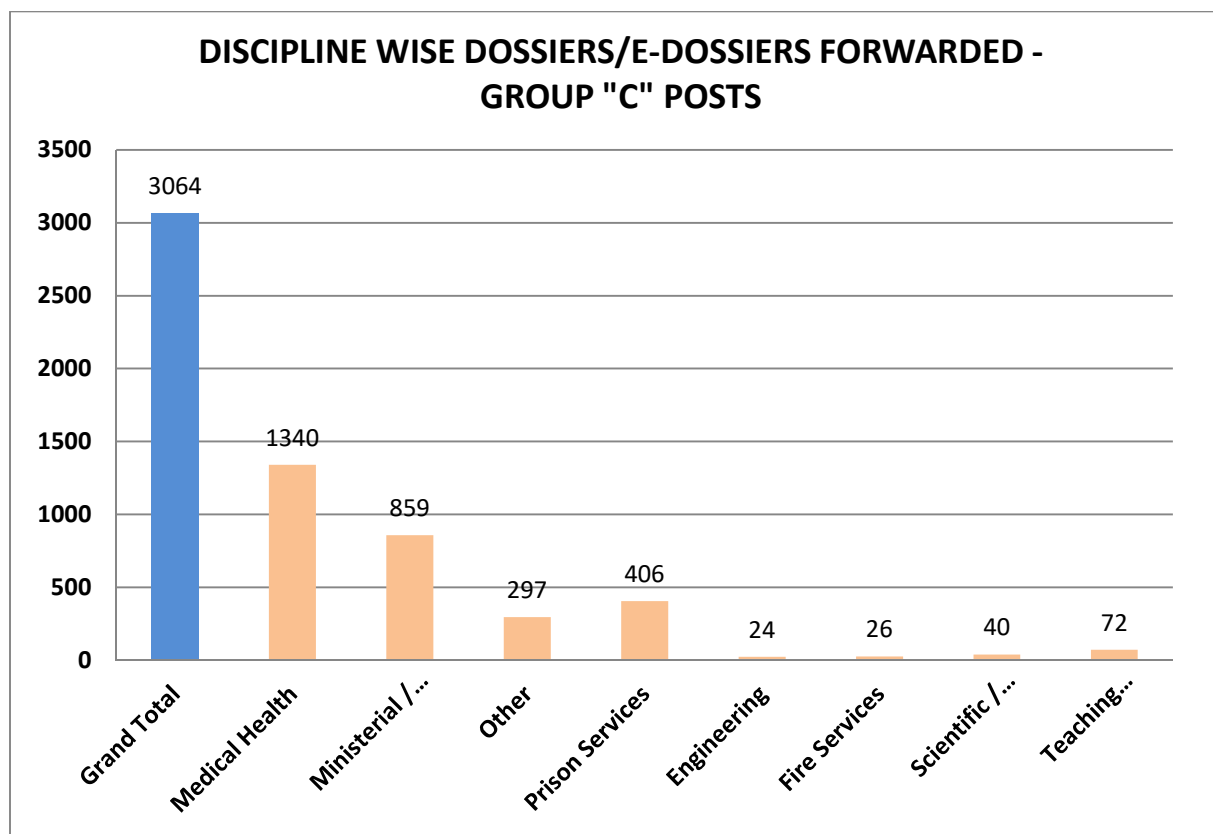

Board has closed results of 57 post codes for 4257 numbers of notified vacancies during the year 2020- 21, including 02 post codes for 39 notified vacancies results for which were declared prior to 2020-21.

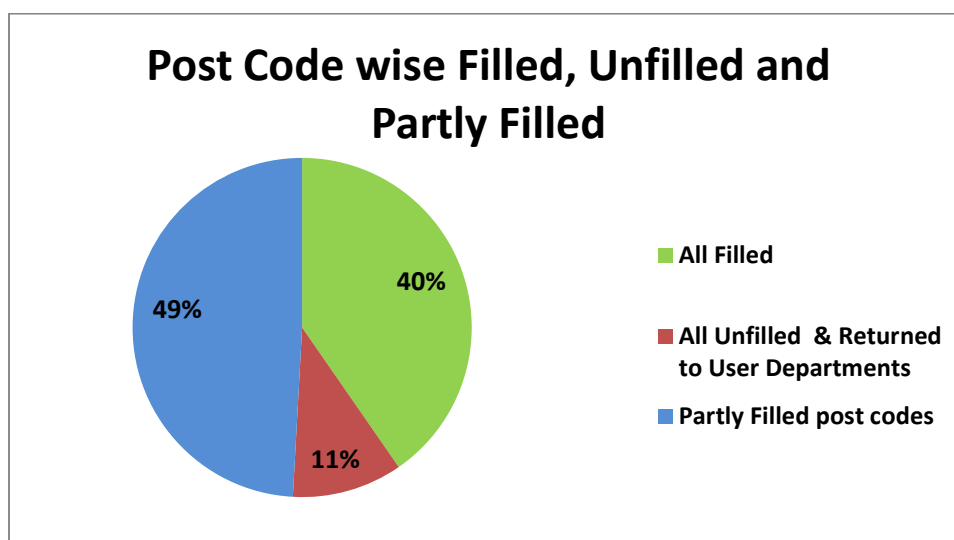
The closure of above results led to return of 808 unfilled vacancies to the user departments for inclusion in subsequent requisitions. **(Appendix – 14).**

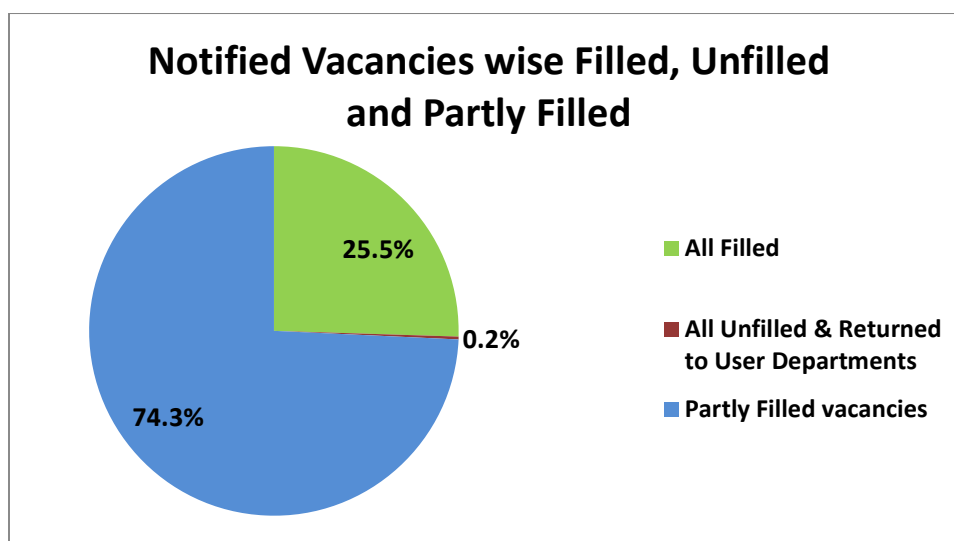

CHAPTER 10

Major Initiatives

A. Computer Based Examination System:

Board has shifted to complete Computer Based Examination System (CBES) from Paper Based Examination (PBE). This makes recruitment process more transparent, quicker and efficient.

B. e-Dossier:

Board has upgraded e-dossier module in OARS system for the shortlisted candidates for submission and resubmission (in case of recalling of documents from provisionally selected candidates) of their educational qualifications and other documents like Caste Certificate, etc for checking their eligibility as per RRs. This facility has greatly reduced time taken for calling and / or recalling of documents and declaration of results thereafter. It also saves time and money of candidates who now can upload their documents online within the prescribed period without visiting the Board on specified dates.

C. Training of Staff:

Board has strengthened the system of training of all exam functionaries to ensure smooth and fair examinations.

D. Frisking/Dress Code:

Board has the system of frisking of the candidates using HHMD at the time of entry and strict dress code so that chances of carrying banned items to the examination hall can be checked.

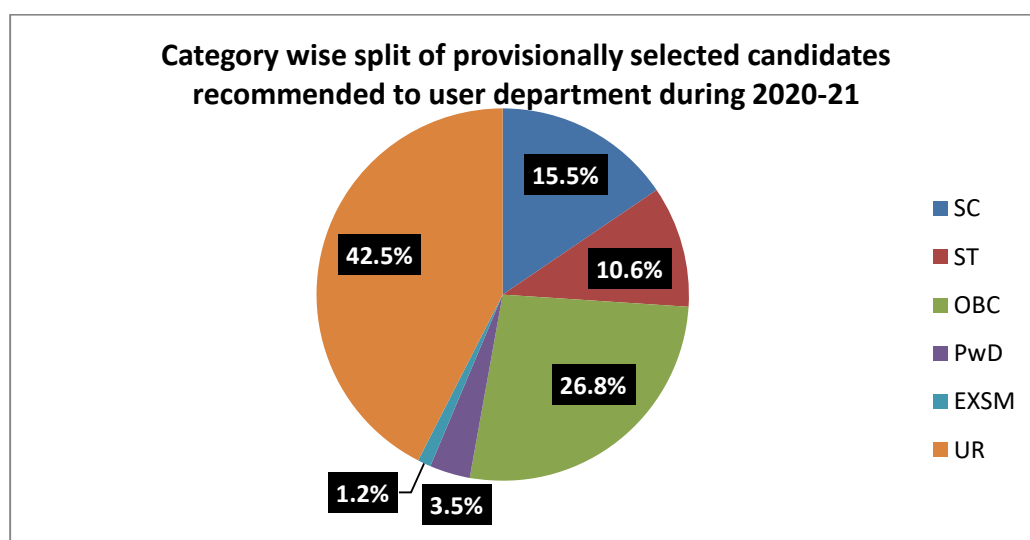
CHAPTER 11

Budget, Income and Expenditure

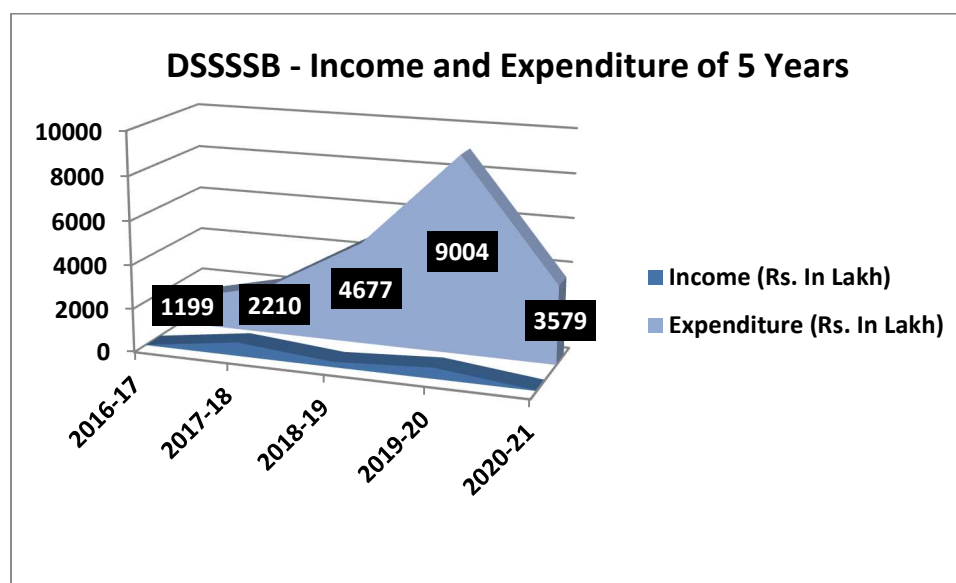

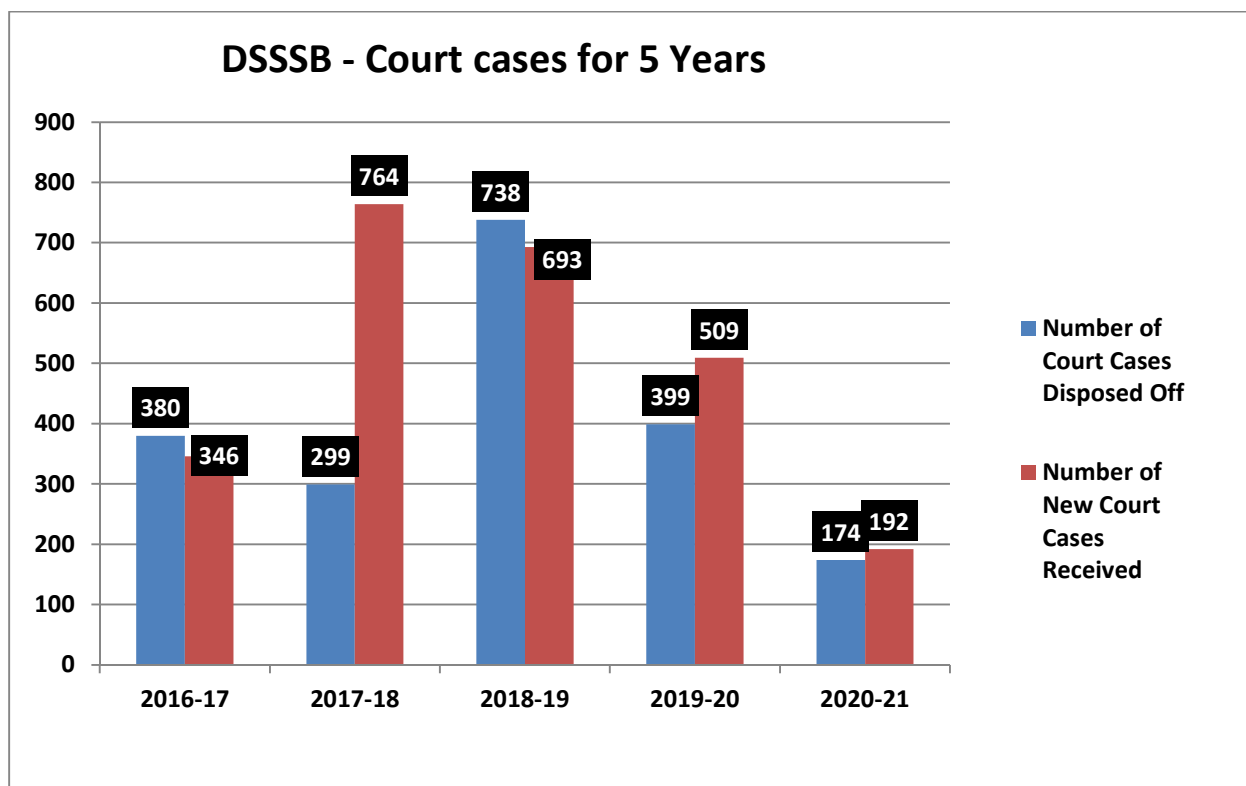

B. Information and Facilitation Counter:

Separately, the Board has also set up an Information & Facilitation Counter at its office for public-interface, transparency in administration, providing easy and speedy access of information to candidates and others in respect of services and activities of the Board. RESOLUTION DATED 04.10.1996

SERVICES DEPARTMENT

No. F-3(7)/93-S.III. – On a careful consideration of the recommendation of the Services Department, the Government of National Capital Territory of Delhi have decided to set up a Selection Board, to be known as “Delhi Sub-ordinate Services Selection Board” hereinafter called Board.

2. **Constitution of the Board:**

The Board will be an attached Office of the Services Department, Government of National Capital Territory of Delhi, and will comprise of a Chairman, a Member (Ad-hoc) and a Secretary cum-Controller of Examinations to be appointed on such terms and conditions as may be prescribed by the Government from time to time. The Board will be provided such supporting staff as may be considered necessary by the Government.

3. **Functions:**

To start with, the Board will select candidates for Group ‘B’ and ‘C’ posts in Municipal Corporation of Delhi (including Delhi Electric Supply Undertaking) and New Delhi Municipal Council. The Board will, among other things, conduct examinations and hold interviews, whenever required in the selection process, according to the relevant Recruitment Rules in accordance with Section 92- A of Delhi Municipal Corporation Act, 1957 and Section 42 of the New Delhi Municipal Council Act, 1994.

Board will take over recruitment to Gr. ‘B’ and ‘C’ posts in different departments of Government of National Capital Territory of Delhi (including Delhi Police) and its autonomous bodies in the jurisdiction of this Board, when approval of Government of India is obtained.

4. **Duties and Responsibilities:**

CHAIRMAN

The Chairman as Administrative head of the Board will be responsible for:-

- (i) Ascertaining from the departments, the number of Group 'B' & 'C' posts for which recruitment is to be made from time to time.
- (ii) Inviting applications by means of advertisements.
- (iii) Scrutinizing applications received in response to the advertisements.
- (iv) Selection of candidates either by competitive examinations or interviews of candidates, or by both.
- (v) Submission to the departments concerned the names of the selected candidates.
- (vi) Taking steps to ensure that in making recommendations, the departments will liable to discharge their obligation in respect of the recruitment of the members of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.
- (vii) Maintaining records of selections made by the Board.
- (viii) Submitting an annual report of the activities of the Board to the Services Department.
- (ix) Any other duty or duties, entrusted by the Government from time to time.

MEMBER (AD-HOC)

- (i) Assisting the Chairman in conducting examinations and interview of candidates as and when necessary. He will sit in the interviews held by the Board as a Member/Expert or Chairman.
- (ii) Any other duty or duties to be assigned by the Chairman, who can delegate any administrative or financial powers exercised by him.

5. Delegation of Powers:

The Chairman of the Board will exercise the administrative and financial powers of the “Head of Department”. The Board will also have a Secretary, who will exercise the powers of the “Head of Office”.

RESOLUTION DATED 12.05.2008

SERVICES DEPARTMENT (III)

No.F.3(24)/DSSSB/2008-S.III/1764.--- In partial modification of resolution dated the 4th October, 1996, the Government of National Capital Territory of Delhi have decided to restructure the Delhi Subordinate Services Selection Board (hereinafter called "Board") as under :

1. **CONSTITUTION OF THE BOARD** – The Board shall continue to be attached office of the Services Department and will comprise of a Chairman, two Members, a Controller of Examinations, a Secretary and supporting staff.
2. **FUNCTIONS** – The Board's function, as at present, is to make recommendations for suitable candidates for Group 'B' and 'C' categories of posts, both technical and non-technical.
3. **DUTIES AND RESPONSIBILITIES OF THE BOARD, CHAIRMAN, MEMBERS, CONTROLLER OF EXAMINATIONS AND SECRETARY** – The duties and responsibilities of the Board and its Chairman, Members, Controller of Examinations and Secretary shall be as given below:-

A – Board

The Board shall

- (i) Recommend suitable candidates for appointment in various departments of government of NCT of Delhi and local bodies/PSUs under the direct recruitment quota to Group 'B' and 'C' categories of posts;

- (ii) be distinct from the Interview Committees. The Chairman, Members and other temporary Expert Members each may head Interview Committees separately. The Board can constitute such numbers of Interview Committees with such Members/Experts, as deemed fit;
- (iii) make recommendation(s) of suitable candidate(s) within 180 days from the date of receipt of an indent for the vacant post(s) from the concerned department(s), bodies and PSU(s) of Government of NCT of Delhi. Delay(s), if any, shall be explained along with submission of the recommendation(s), giving necessary justification(s);
- (iv) utilize state of the art techniques including IT. Enabled services for increasing its efficiency, effectiveness and transparency for evaluating candidates as deemed fit;
- (v) consider the feasibility of utilizing the services of specialist agencies/human resource agencies available within the Government or from outside for (iii) above;
- (vi) perform any other related task entrusted to it subject to guidelines issued by the Government from time to time for making recommendations of candidate for vacant Group 'B' and 'C' categories of posts.

B – Chairman

The Chairman of the Board

- (i) will be primus inter pares in the Board and be a person of stature in the field of public service;
- (ii) will preside over Board meetings;
- (iii) will exercise administrative and financial powers of the Head of Department on behalf of the Board and take into account the recommendations of the Controller of Examinations and the Secretary of the Board;

- (iv) may be appointed on deputation / re-employment / extension of service;
- (v) will perform his/her duties for a period of five years in the Board or till he/she attains 65 years of age, whichever is earlier. However, the Government of NCT of Delhi reserves the right to withdraw the services of Chairman at any time, without assigning any reason;
- (vi) shall, on the expiration of his/ her term of office, be ineligible for re-appointment to that office.

C – Member

- (i) There will be two Members apart from the Chairman, one Member would preferably be a woman and other Member preferably from the reserved category or minority category;
- (ii) Members will assist the Chairman in conducting examinations and other selections tests, including interview of candidates, wherever necessary;
- (iii) Members will perform such other functions as may be assigned to them by the Chairman;
- (iv) Members will be persons of eminence in their respective fields;
- (v) Members may be appointed on deputation / re – employment / extension of service;
- (vi) A member will perform his / her duties in the Board for a period of five years or till he/she attains 62 years of age, whichever is earlier. However, the government of NCT of Delhi reserves the right to withdraw the services of a Member at any time, without assigning any reason;
- (vii) A Member shall, on the expiration of his/ her term of office be ineligible for re-appointment to that office.

Note: The combined term of a member in case he/she was to become Chairman will also not exceed five years in the Board.

D – Controller of Examinations

The Controller of Examination shall report to the Board and shall be responsible for all matters relating to examinations such as preparation of confidential papers, registration of candidates, conduct of examinations, evaluation, publication of results and issue of results. He shall recommend and also ensure the process of up gradation and reforms of examination procedures subject to the approval of the Board. He shall also introduce and implement changes, retrofit, computerization, IT enabled objective type, scientifically designed modules to make the examinations procedure precise, scientific, fair and above all merit based. In particular, he/she shall be responsible for-

- (i) ascertaining in advance the requirement of various departments, bodies and PSUs of the Government of NCT of Delhi so as to make recommendations within time and in the prescribed manner;
- (ii) preparing schedule of examinations;
- (iii) release of advertisements/ vacancy circulars in the media;
- (iv) scrutiny of applications of candidates;
- (v) conducting examinations, skill tests and/or interviews of candidates;
- (vi) publications of results;
- (vii) forwarding of list of recommended candidates to concerned departments/bodies/ PSUs within 180 days of the requisition received;
- (viii) ensuring implementation of reservation in respect of members of the Scheduled Castes, Scheduled Tribes, Others Backward Classes and other categories as per guidelines/norms/circulars/ notification issued by Government from time to time;
- (ix) maintaining records of all examinations conducted by the Board;
- (x) any other duty(s) or responsibility(s) entrusted by the board from time to time.

E – Secretary

The Secretary of the Board shall report to the Chairman of the Board and shall –

- (i) exercise administrative and financial powers as Head of the Office;
- (ii) assist the Chairman in the day to day functioning of the Board;
- (iii) receive or cause to receive all petitions, applications or references pertaining to the Board;
- (iv) submit an Annual Performance Report on the major activities of the Board to the Services Department and other authorities as prescribed from time to time;
- (v) perform any other duty(s) or responsibility(s) entrusted by the Board/Government from time to time.

The supporting staff strength of the board shall be raised from the existing 58 personnel to 121 personnel. The number of staff would be enhanced as per requirement from time to time.

The post of Chairman and two Members shall be created and notified after obtaining due approval/concurrence from the Ministry of Home Affairs, Government of India.

NOTICE No. F.04 (100)/2013/P&P/NES/DSSSB/440-445

The Delhi Subordinate Services Selection Board (DSSSB) had notified a New Examination Scheme vide notification no. F.4(100)/2013/P&P/NES/DSSSB/44-54 dated 14.02.2013 for recruitment to various posts to be made by the Board. The scheme had been made applicable w.e.f.01.01.2013.

Instructions of DoPT, Government of India vide OM No. 39020/01/2013-Estt(B)-Part dated 29.12.2015 were forwarded to the Board by Services Department as per which interview is not to be conducted for recruitment upto the level of Group B Posts. At present, the Board has prescribed interview as the 3rd tier of exam process for some Group 'B' posts. Further, interview is also being conducted for selection of candidates of scientific and technical posts, either alone or after a written screening, if the number of candidates is less than 500. After issue of aforesaid instructions by the Government, the interview method can no longer be used.

The Board (DSSSB) vide resolution no. P&P/2017/12 dated 25.05.2017 has decided to dispense with the interview from the selection process in respect of all posts. As such, selection process in respect of posts having three tier examination scheme, whether already advertised with such scheme and/or posts where selection process is in mid-way, shall be converted into two-tier examination scheme with immediate effect and the final selection shall be made based on merit in Tier-II examination.

Further, all posts for which screening test has been conducted and it was to be followed by interview, the screening test shall be disregarded/scrapped and selection shall be made as per the general scheme of exam prescribed for that post for number of candidates is more than 500.

The Delhi subordinate Services Selection Board (DSSSB) had notified a New Examination Scheme vide notification no. F.4(100)/2012/P&P/NES/DSSSB/44-54 dated 14/2/2013 for recruitment to various posts to be made by the Board. The scheme had been made applicable w.e.f. 01/01/2013. In continuation of the NES, the Board framed the Interview policy in the year 2014.

In compliance of DoPT OM No. 390/01/2013-Estt(B)-Part date 29/12/2015, the Board vide resolution no. P&P/2017/12 dated 25/05/2017 decided to dispense with the interview from the selection process in respect of all posts and a notification dated 02/06/2017 in this regard had already been issued.

There are some post codes wherein interview was to be conducted but interview process did not start prior to the aforesaid DoPT notification. The matter had been reviewed by the Board and it has been decided vide resolution no. P&P/2017/18 dated 17/07/2017 as under:-

A. For pending posts where Interview was to be conducted:

- (i) In case of posts where the selection process was based on One Tier examination, as per New Examination Scheme 2013, the same may be followed.
- (ii) In case of post codes, where the selection process was based on Two Tier examination or Three Tier examination, as per New Examination Scheme 2013, but the number of candidates are low in number, in such cases it has been decided to dispense with the Tier-I examination in respect of these post codes and selection may be made directly through Tier-II examination.

B. For other posts:

In case of the posts, whether technical or general, where the selection process is based on Two/Three Tier examination as per New Examination Scheme 2013 but the number of eligible candidates are not very high, in such cases the Board decided to dispense with the Tier-I examination in respect of these post codes and the selection may be made directly through Tier-II examination.

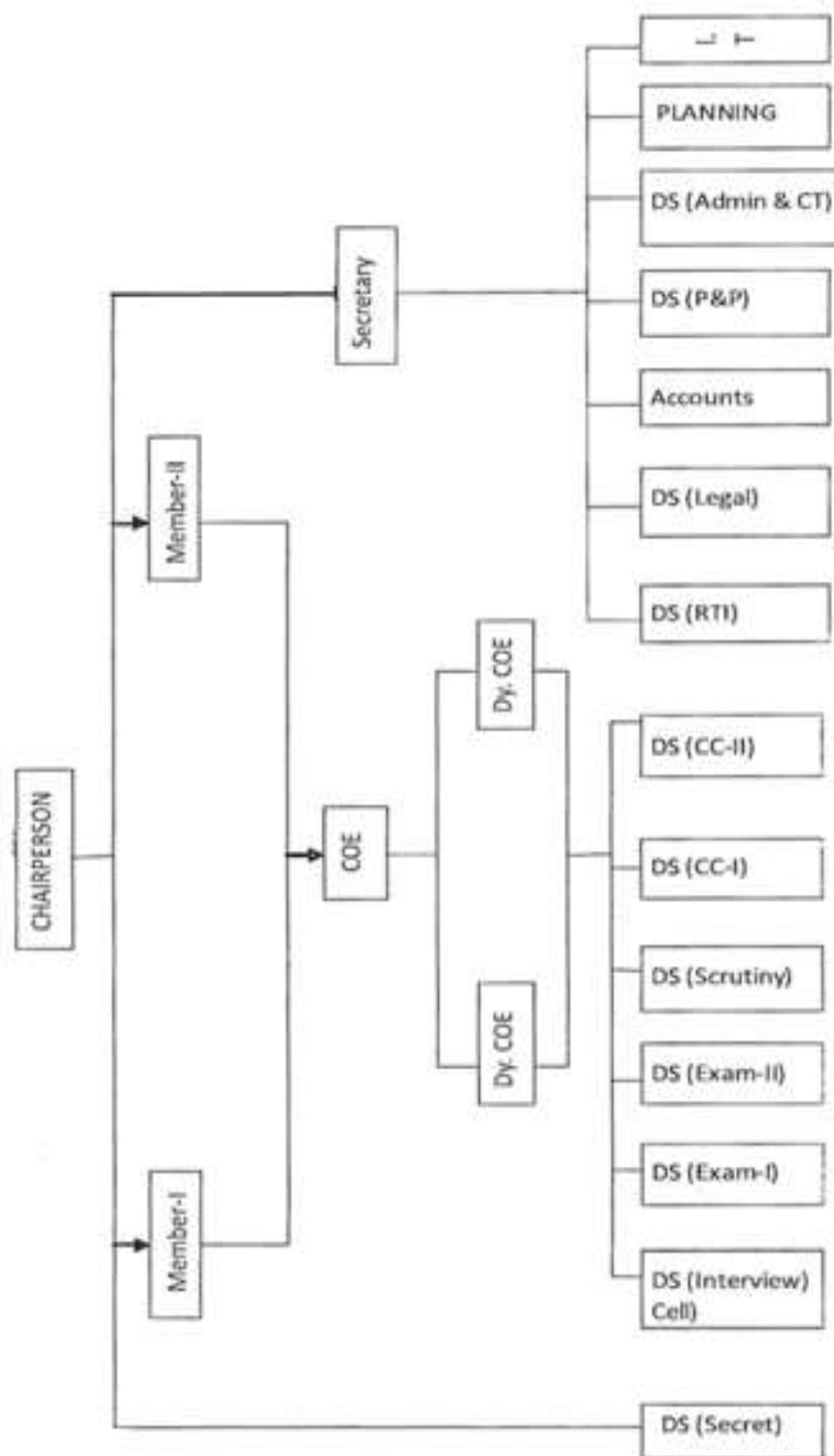
