ORDER.

The Ld CAT in the matter of Rakesh Kumar V/s DSSSB in OA 582/2017, vide its order dated 17.02.2017 has directed as under:-

"The applicant made number of representations and legal notice dated 09.01.2017 ventilating his grievances. However, the respondents have not passed any orders thereon till date.

In the circumstances, the O.A. is disposed of at the admission stage itself, without going into other merits of the case, with a direction to the respondents to consider the representations of the applicant and to pass appropriate speaking and reasoned order thereon, in accordance with law, within a period of 90 days from the date of receipt of a copy of this order. No order as to costs"

In compliance of above order, the following is stated:

Sh. Rakesh Kumar having Roll No 59000297 was the candidate for the post of MVI had obtained 116.00 marks in Tier-II exams and was in the zone of selection in OBC category, accordingly, he was initially provisionally selected vide Result Notice No 341 dated 13.10.2015 in postcode 42/13.

On receipt of a representation from Sh. Rahul Sharma having Roll No 59000009, who had obtained 116.25 marks in Tier-II exam to consider him for the post of MVI in post code 42/13, the candidature of Sh. Rakesh Kumar was cancelled and was kept in OBC category as panel-I, vide corrigendum dated 16.10.2015. Therein, the candidature of Sh. Rahul Sharma was also kept pending for want of documents.

Now, the candidature of Rahul Sharma has been cancelled vide Result Notice dated 02.03.2017, as he do not possess the requisite essential working experience as per the RRs of the post.

The applicant Sh. Rakesh Kumar was shortlisted under OBC category as per marks obtained in Tier-I exams for appearing in Tier-II exams. The applicant had obtained 116 marks in Tier-II exam. His candidature cannot be considered under vacant post in UR category created by cancellation of

candidature of Sh. Pradeep Kumar as he was shortlisted in OBC category and he is below merit.

On detailed scrutiny of dossier of Sh. Rakesh Kumar, it is observed that the experience certificates furnished by the candidate as "Senior Instructor" and "Service Advisor" does not relate to the experience as required in the RRs for the post of MVI. Since, the candidate do not have the five years experience as required in the RRs, therefore, the candidature of candidate Sh Rakesh Kumar is not eligible for the post of MVI.

This issue with prior approval of the competent authority.
