**ORDER.**

Sh. Deepak Kumar having Roll No 59000155, the candidate for the post of MVI had scored 103.5 marks in Tier-I examination. As per data provided earlier the name of candidate was shown as candidate for the post of MVI under post code 42/13 only. Accordingly, the applicant was shortlisted only for appearing 42/13 vide Notice dated 05.03.2015.

The applicant appeared in Tier-II examination and had obtained 115 marks. At the time of declaration of final result in 2015, the last selected candidate under OBC category in post code 42/13 was having 116.75 marks, as such the applicant was not considered for the post under OBC category being lower in merit for post code 42/13 having obtained 115 marks.

The claim of the applicant that he had applied to the post of 21/12 have been ascertained that Sh. Deepak Kumar had applied manual application for the post of MVI under post code 21/12 vide I.D. No 2133295. Accordingly, on the analogy of the judgment dated 27.11.2015 of Hon'ble High Court in the matter of Vikas Choudhary in WPC No 9869/2015, the Board is considering the candidature of the applicant for the post of MVI under post code 21/12.

In post code 21/12, the cutoff marks in Tier-I for shortlisting the candidate for appearing in Tier-II exam was 82 marks for UR category and 64.25 for OBC category whereas the Sh Deepak Kumar had scored 103.5 marks. As such the candidate fulfill the shortlisting conditions.

In post code 21/12, the Tier-II exam marks of last selected candidate in UR category was 97.75 marks and in OBC category it was 89.25 marks. Accordingly, the candidature of candidate has been considered in OBC category under postcode 21/12.

While examining the dossier of Sh. Deepak Kumar, it has been observed that candidate possesses the experience certificate prior to date of acquiring educational qualification. Also the candidate had furnished the experience certificate working as 'Supervisor Trainee' in M/s Maruti Sales & Service w.e.f. 22.09.2001 to 03.05.2002; as 'Supervisor' in M/s 'Engineer's Automobiles' w.e.f. 18.01.2003 to 30.08.2005, as 'Supervisor' in M/s D.D. Motors w.e.f. 01.09.2005 to 03.05.2006; as 'Assistant Supervisor' w.e.f. 09.05.2006 to 28.10.2006 in M/s Maruti Service Masters,

as 'Floor Incharge' w.e.f. 03.11.2006 to 16.10.2007 in M/s 'Master Automobiles' and also as 'Craft Instructor' in C.V. Raman Industrial Training Institute from 19.12.2007 to 02.04.2012. The experience certificates furnished by the candidate do not indicate that the candidate has essential experience as per the working experience as per RRs. Therefore, the candidature of Sh. Deepak Kumar is rejected for the post of MVI in post code 21/12.
