ORDER

Whereas Sh. Surgyan Singh Meena, Roll No. 00326828 was a candidate for the post of Fire Operator advertised by the Board under post code no. 003/09 vide Advt. No. 001/09.

Whereas Sh. Surgyan Singh Meena qualified in the Part-I(Preliminary) and Part-II(Main) examination as well as skill tests i.e. PET (Physical Endurance Test) and Driving Skill Test which were conducted for selection to the post of Fire Operator, Post Code 003/09.

Whereas Sh. Surgyan Singh Meena was in the zone of consideration under the UR category on the basis of marks secured by him i.e. 107/200 marks in the Part-II(Main) examination for post of Fire Operator, Post Code 003/09.

Whereas the result of post of Fire Operator, Post Code 003/09 was declared vide Office Order No. 199 dated 25-11-10 wherein the candidature of Sh. Surgyan Singh Meena was kept pending under the UR category due to inconsistency in respect of signatures, handwritings etc. alongwith other similar candidates.

Whereas the case of Sh. Surgyan Singh Meena was referred to a Verification Committee consisting of the Dy. Secretaries of the Board.

Whereas vide Rejection Notice vide Office Order No. 215 dated 10-06-2011, the candidature of Sh. Surgyan Singh Meena was rejected for having put his signature in block capital letters on the application form, admit cards, answer sheets etc. in violation of the specific condition laid down in the advertisement no. 001/09 of the post of Fire Operator, Post Code 003/09.

Whereas vide order dated 10-01-14 in OA No. 517/2013, MA No. 374/2013, MA No. 375/2013, the Hon'ble CAT observed that the High Court has held that in such cases application cannot be rejected and allowed the OA and remitted back the matter to the Board to do the needful within two months next.

Whereas the recruitment process in respect of post of Fire Operator under post code 003/09 has been closed by the Board.

Whereas subsequently another advertisement for the same post of Fire Operator was issued by the Board for 803 vacancies (UR-290, OBC-126, SC-282, ST-105) under post code 71/14 vide Advt. No. 01/14 on the basis of requisition received from the user department i.e. Delhi Fire Services, GNCTD.

Therefore, now the Board in compliance of Hon'ble CAT's order dated 10-01-14 in OA No. 517/2013, MA No. 374/2013, MA No. 375/2013 hereby selects Sh. Surgyan Singh Meena

provisionally and also enclose his dossier for the post of Fire Operator, Post Code 003/09 subject to the availability of vacancy under the Post Code 003/09 at user's department and also subject to the verification of Driving License. Driving License to drive transport vehicle is valid from 26-09-2008 to 25-09-2011 and issued from Licensing Authority, Karauli, Rajasthan.

The provisional selection of the above candidate shall also be subject to fulfilment of all the eligibility conditions as prescribed by the statutory RRs and terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application forms, admission certificates etc. The candidature of the candidates are liable to be cancelled by the user department also, in case the candidate is found not to be fulfilling the eligibility conditions or due to any other genuine reason. The Competent Authority of the department concerned shall issue the appointment letter to the candidate after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information/documents/Caste Certificate furnished in the application forms. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

If due to non availability of vacancy under post code 003/09 or any other reason/condition as stated above, the candidature of Sh. Surgyan Singh Meena is rejected/cancelled by the user department i.e. Delhi Fire Services, GNCTD, the letter of rejection/cancellation and the dossier would be returned to this department within scheduled time by the user department.

This issues with the prior approval of the Competent Authority of DSSSB.
