**INSTRUCTIONS TO CANDIDATES FOR PHYSICAL ENDURANCE TEST (PET) FOR THE POST OF SUB-OFFICER IN DELHI FIRE SERVICE UNDER POST CODE NO 52/09 AND SUB-FIRE OFFICER IN NDMC UNDER POST CODE 76/09**

1. The Physical Endurance Test for the post of Fire Operator has been fixed from 29.05.13 at Chatrasal Stadium, Model Town, Delhi-09. The reporting time at the test centre will be 8.00 AM to 8.30 AM. The Test will commence at 9.00AM sharp. Entry to the test centre will be closed at 8.30 AM for candidates. No candidate will be allowed to enter the test centre after 8.30 AM under any circumstances.
2. Based on result of Part II (Descriptive) examination held on 21.08.11, candidates have been declared provisionally qualified for appearing in Physical Endurance Test which is qualifying in nature, as per recruitment rules (notified vide Advt. No. 01/2009 in Employment News, dated 7-13 Feb, 2009 for selection to the post of Sub-Officer (Post Code-52/09) and Advt. No.04/09 in Employment News dated 25<sup>th</sup> Dec,09 to 1<sup>st</sup> Jan,10 for the selection to the post of Sub-Fire Officer in NDMC(Post code-76/09).
3. Admit Cards are being sent to candidates. The Board is not responsible for any postal delay/loss. The candidates, who do not receive their Admit Cards by 26.05.13 may visit the Board **in person** at above address on 27.05.13 between 10: 00 AM to 5:00 PM along with identity proof and the proof of having applied for the post for obtaining duplicate Admit Cards.
4. If any candidate appearing for the above P.E.T., finds that his name, reservation, category, post name, post card, photo, signature missing or incorrect in his admit card, he should get it rectified from the office of the Board on the date and time mentioned in point 2. Any modification of the admit card at the examination centre will not be allowed.
5. No candidate, without valid original Admit Card issued by the Board, shall be allowed to enter into the test venue. Photocopy of Admit card is not permissible.

- 6 Any kind of malpractices such **as impersonation/ canvassing/ doping etc**, shall invite penal action including rejection from present test as well as debarring from future examinations.
- 7 The candidature of the candidates to the Physical Endurance Test is entirely provisional and subject to the outcome of direction/decision/order/pronouncement of any court of law and mere issue of admit card or appearance at the test does not entitle the candidates to any claim for the post.
- 8 The Board reserves the right to cancel a part of or entire process of test due to administrative reasons and in case of unfair means cheating or other irregularities/ malpractices noticed by the Board. The Board also reserves the right to cancel Test Venue or set up a new centre and divert the candidates to appear at new Test Venue, if required. No request for change in date, time and centre of test will be accepted under any circumstances.
- 9 The Board reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment /selection.
- 10 Any dispute with regards to this recruitment will be subject to Courts/tribunals decision having jurisdiction over Delhi.
- 11 No TA/DA is admissible to any candidate for appearing in the test.
- 12 The candidate should scrupulously follow these instructions and also that of the designated officers of the Board at the Test Venue failing which the candidature of the candidate may be cancelled.
- 13 Candidates shall have to submit a sample of their writing (Hindi and English Both) before commencement of the Physical Endurance Test. Candidates will have to write in the presence of observer/ designated officer of DSSSB on the paper /format provided by the DSSSB.**
- 14 Candidates shall bring with them copies of all documents supporting their candidature for the post, with one recent attested photograph (duly attested by Gazetted officer ) on the day of physical Endurance Test.**
- 15 Candidates should also bring his /her Photo Identity proof in original .**

**“ PHYSICAL ENDURANCE TEST”**

- A) **Physical Standards** : The candidate have to attain the minimum physical standards as prescribed below:-

1. **Minimum Height:** 165 cms (Relaxable to 5 Cms for hilly area people).
2. **Minimum weight** : 50 kgs.
3. **Chest (Normal)** : 81Cms, **Chest (expanded)** : 86.5 Cms.
4. **Eye Sight** : 6/6 without any correction.

B) **Physical Endurance Test (PET):** The PET would be of qualifying nature and the candidate will have to attain the minimum qualifying standard as given below :
