SUPPLEMENTARY RESULT NOTICE NO: 899 FOR THE POST OF DRAWING TEACHER, POST CODE-91/17 IN DIRECTORATE OF EDUCATION.

- 1. The board in compliance of the directions of the Hon'ble CAT in O.A. No. 1843/2019 in the matter of Parul Rathi & Ors. vs. Govt. of NCT of Delhi & Ors has granted relief to 22 candidates by provisionally nominating them vide compliance result notice no. 867 dated 20.05.2022 for the post of Drawing Teacher, post code 91/17. Accordingly, the User Department i.e., Directorate of Education after getting necessary approval through the Hon'ble LG, GNCTD has granted one time relaxation in terms of Recruitment Rules in Post Code 91/17, Drawing Teacher. The said relaxation is subject to the concurrence of UPSC, as a onetime measure not to be quoted as a precedent in compliance of Judgment of Hon'ble Court.
- 2. In light of the Judgment dated 11/07/2022 passed by Ld. Tribunal in OA No. 1717/2022 titled as "Shushil Bhambhu & Ors vs GNCTD & Ors", two more candidates were granted relief by provisionally nominating them vide result notice no. 896 dated 23/12/2022 and they were issued offer of appointment by User Department i.e., Directorate of Education by extended the relief in terms of RRs, approved by Hon'ble LG, GNCTD.
- 3. Now, the User Department i.e., Directorate of Education vide its letter dated 3/02/2023 has informed about the approval of Hon'ble LG whereby the relaxation in terms of RRs of Drawing Teacher of post code 91/17, subject to the concurrence of UPSC, as a onetime measure only is also extended to similarly placed candidates of post code 91/17 of Drawing Teacher, whose candidatures were rejected on similar grounds, but who have not approached the courts for relief. Accordingly, the user department has requested to forward the dossiers of similarly placed candidates in the matter of OA No. 1843/2019 and OA No. 1717/2022 case titled as "Parul Rathi & Ors vs GNCTD & Ors" and "Sushil bhambhu vs GNCTD & Ors" so that approval/direction of Hon'ble LG are complied with.
- 4. Therefore in pursuance of the letter dated 3/2/2023 of Directorate of Education vide which the Hon'ble LG has accorded his approval to those candidates who were rejected on similar grounds, but who have not approached the courts for relief by granting one time relaxation in RRs of Drawing Teacher, post code 91/17, the candidature of 18 similarly placed candidates as per details given below is revived by rescinding the Rejection Notice no. 445 dated 27/05/2022 and Rejection Notice no. 618 dated 16/3/2020 for the post of Drawing Teacher, Post Code 91/17.

5. Accordingly, the following 18 candidates are hereby provisionally nominated who are otherwise eligible for the post of Drawing Teacher, Post Code-91/17 in Directorate of Education.

- 6. The selection of the above 18 (UR-10, OBC-01, SC-05, ST-02) shall be subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 7. The selection of the above 18 (UR-10, OBC-01, SC-05, ST-02) candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidates is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- The user department shall also check the eligibility of the reservation 8. benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the edossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 10. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

- 14. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.

- 16. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post code.
- 17. The recruitment process for the post of Drawing Teacher, Post Code-91/17 henceforth closed. Further, the Wait List panel of the candidates has already been expired which was valid upto 26.05.2020 and extended upto 31.12.2020 which has also expired.
