**TEACHER (PRIMARY)**  
**IN MUNICIPAL CORPORATIONS OF DELHI (MCD)**  
**UNDER POST CODE-16/17 & 01/18**

1. This is in continuation of the Result Notice No. 788 dated 31/07/2019.
2. The DSSSB, vide its advertisement No. 02/2017 had advertised 4366 vacancies (UR-1610, OBC-1286, SC-714, ST-756 including PH-VH-288) for the post of Teacher (Primary) under post code 16/17, in MCD, read with Notice dated 28/07/2017. Later on, in supersession of the vacancy notice for the post code 16/17, Board had advertised afresh **4366 vacancies (UR-1610, OBC-1286, SC-714, ST-756 including PH-VH-381, PH-OH-93)** for the post of Teacher (Primary) under post code **01/18** in MCD vide its Advertisement No. 01/2018.
3. The DSSSB vide addendum No. F.2(164)/DSSSB/P&P/17/1176 dated 11/02/2019 has revised the vacancies in respect of PH-OH Category only. Now, the vacancies in respect of PH-OH category may be read as 133 instead of 93. However, the total number of vacancies shall remain the same.
4. Further, vide Notice no. 760 dated 01.02.2019, a total of 8673 candidates were called for uploading the dossier w.e.f. 05/02/19 to 14/02/19 and vide subsequent Notice no. 765 dated 15/02/2019 a total of 80 candidates were called for uploading the dossier w.e.f. 18/02/19 to 27/02/19. The Results for above post were declared vide **Result Notice No. 773 dated 28.03.2019 and subsequent supplementary Result Notices No. 774 dated 16.04.2019, No. 775 dated 09.05.2019, No. 785 dated 12.07.2019 and No. 788 dated 31/07/2019.**
5. The result has been processed keeping in view of the eligibility conditions regarding educational qualifications / caste certificate / disability certificate etc. as on cut off date i.e. 15/09/17 for post code-16/17 and 30/07/2018 for post code-01/18.
6. On the basis of marks secured in written examination and after preliminary scrutiny, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following **19 candidates [UR-05, OBC-03, SC-04, ST-03, UR-PHOH-01 and OBC-PHOH-03]** are provisionally selected for the post of Teacher (Primary) under post code 16/17 & 01/18 in MCD, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application forms and e-dossiers :-

The above pending **total 02 candidates i.e. having Roll No. 2800032109 and 2800024005 in OBC Category and 01 candidate having Roll No. 2800021462 in SC category** are directed to upload their pending documents/ all requisite / applicable documents etc. if any, through the e-dossier module in stipulated time failing which his candidature will be rejected without any further notice.

19. The e-dossier link shall be active from **25.10.2019** The above candidates are also being separately informed through, SMS and on their registered mobile number. **If, any candidate fails to upload required documents through e-dossier during the above said period his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.**

20. The selection of the above **19 (Nineteen) candidates [UR-05, OBC-03, SC-04, ST-03, UR-PHOH-01 and OBC-PHOH-03]** shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

21. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after verification of the correctness of the information furnished in the application form and the documents related to educational qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54.

22. **The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents**



as furnished in the application forms and e-dossier vis-à-vis the original documents. MCD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

23. It is stated that the User Department i.e. MCD shall verify the genuineness of the caste certificate furnished by the candidates in the light of Notification No. 36012/22/93-Estt.(SCT) dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the user department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.
24. User Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013.
25. **The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.**
26. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
27. **The recruitment process for the post code-16/17 & 01/18 had already been closed subject to disposal of above pending cases and subject to outcome of pending court cases, if any.**
