**ORDER**

Whereas the Delhi Subordinate Services Selection Board had advertised 39 (UR-32, SC-07) vacancies for the post of Junior Engineer (E&M) (Post Code-14/12) vide its advertisement no. 02/12 in the year 2012 and the candidates were screened through a written examination held on 28.12.2014.

Whereas the marks list of all the candidates was uploaded on the Board's website on 04.03.2015 but marks list of 07 candidates was not uploaded and kept in CD in sealed cover as per directions of the Hon'ble CAT.

Whereas the candidate Sh. Sandeep Kumar has filed the petition in the Hon'ble CAT to allow the applicant to participate in the interview.

Whereas the Hon'ble CAT has disposed of the petition with the direction that "the applicants to make individual representations to the Board within one week from today and a direction to the Board to decide the same within three weeks thereafter by way of reasoned and speaking order. It is made clear that the time limit of three weeks is outer limit for disposal of the representations and in such cases where the dates of interview have been finalized the respondents may consider the representations on priority.

In view of the above direction of the Hon'ble CAT, the representation of Sh. Sandeep Kumar has been examined and the brief facts of the case are as under:-

As per the approval of Hon'ble LG, the candidates were shortlisted 06 times of the total vacancies against the vacancy in each category (UR, SC/ST/OBC). While short listing the candidates, the candidates of UR category who have secured 40% marks or above were taken into consideration. Candidates of SC category who have secured 30% marks or above were short listed. Hence, 192 candidates were called provisionally for interview against UR vacancy & 42 candidates were called provisionally for interview from SC category. The candidates were shortlisted in accordance with the Board's policy dated 25/07/2014 in para 3 which states that "Where selection is based on academic record and interview or screening test followed by interview/academic assessment and interview, the qualifying marks for the interview will be same as for written examination i.e. 40% for UR, 35% for OBC and 30% for SC/ST/PH". However, the marks of the applicant were checked on the above criteria and it was found that the

applicant has qualified the screening test held on 28.12.2014 but could not come in the merit list of UR/SC category.

Further, as per the direction of the Hon'ble CAT in O.A. No. 4688/2014 dated 26.12.2014, the result of the examination/screening test cannot be declared till further order to be passed by the Hon'ble CAT.

In view of above, the candidate Sh. Sandeep Kumar was not called for the interview. The representation of Sh. Sandeep Kumar is accordingly disposed off.
