Sub:- Notice for release of marks of Tier-1 exam held on 20/06/2022 for the Post of Assistant Law Officer/Legal Assistant under post code 805/22.

- 1. The DSSSB vide advertisement no. 05/22 dated 03/01/2022 with closing date 09/02/2022 had advertised 26 vacancies (UR-20, OBC-04, SC-02 including PWD (VH)-01) for the Post of Assistant Law Officer/Legal Assistant under post code 805/22.
- 2. The prorated marks obtained by 1461 candidates who appeared in written examination held on 20/06/2022 have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module <a href="www.dsssbonline.nic.in">www.dsssbonline.nic.in</a>
- 3. Based on the performance in Tier-I written examination (online mode), out of these 1461 candidates 343 (Three Hundred Forty Three) candidates have been provisionally shortlisted to appear in Tier II examination subject to correctness of the information furnished by the candidates in their online application forms regarding age, education qualification, experience, caste etc.
- 4. The shortlisted candidates shall be called for Tier-II examination separately
