ORDER

On scrutiny of biometric reports taken during the process of examination conducted by DSSSB for Post Code 140/17, TGT (Hindi) and after joining the service in Directorate of Education, Govt. of NCT of Delhi, it is observed that report of biometric examination conducted during the process of examination and subsequently upon his selection to the said post & joining the government service in Directorate of Education in respect of **Mr. Vinay Kumar Gupta S/o Sh. Ram Avtar Vaishya**, whose details are mentioned in table below, is found mis-matching which indicates that candidate appeared in examination is different from the candidate joining government service. Thus, it is a crystal clear case of impersonation indulging in using of unfair means in examination to achieve the employment in government by way of adopting malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the process of examination of above said post code.

The user department has terminated his services on the basis of contradictory biometric report. <u>Thus a case of impersonation.</u>

Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/herself liable to criminal prosecution, be liable:"

- To be disqualified by the Board from the examination for which he/ she is a candidate as also from any other examination/selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or
- To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
- To take disciplinary action if he/she is already in service under Government and or,
- To take any other legal action'

Thus, it is clear that the candidate had arranged to have another person taking examinations in place of him/her. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- i) Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.
- ii) Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii) Helping or receiving help from other candidates to impersonate.
- iv) Signing/ getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v) Providing admit card to another person to enable him to appear on behalf of the candidate.


Further, this candidate have also indulged in the act of **FORGERY and UNLAWFUL ACT** by altering the identity proof of candidates, admit cards etc, and produced these documents to the examination conducting functionaries with the intent to defraud, as on the basis of documents produced which are materially different from the records available and the candidate has already been terminated from his service by the Directorate of Education, Govt. of NCT of Delhi.

Therefore, it is evident that the candidate along with impersonator was actively involved in the **crime related to impersonation, cheating, forgery, connivance and conspiracy** as specified in Indian Penal Code.

In view of above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the candidates.

The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view the above **Mr. Vinay Kumar Gupta** S/o Sh. Ram Avtar Vaishya having Date of Birth : **12/11/1993** bearing Roll No. 110314000196 of Post Code 140/17, TGT (Hindi), Male Directorate of Education, Govt. of NCT of Delhi is hereby debarred from any examination conducted/to be conducted by the DSSSB **for lifetime w.e.f. 28.08.2018**. Further the candidature of **Mr. Vinay Kumar Gupta** will be deemed cancelled if he has appeared in any exam conducted by DSSSB prior to above date.


