ORDER

During the course of evaluation of the OMR answer sheets of the exam held on 24.11.2019 for the post of Welfare Officer/Probation Officer/Prison Welfare Officer, Post code 14/19 it has been found that **Mr. Harish Yadav and Mr Vijay Bhan Maurya**, whose details are mentioned in table below, were found indulging in unfair means, malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the above said post code exam.

Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/herself liable to criminal prosecution, be liable:"

- a) To be disqualified by the Board from the examination for which he/ she is a candidate as also from any other examination/selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or
- b) To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
- c) To take disciplinary action if he/she is already in service under Government and or,
- d) To take any other legal action'

Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post Codes in online, offline & PET examination.

If any case of impersonation comes to notice then Overall In-charge & Observer shall lodge FIR against both persons i.e. candidates who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/ Commissions."

The candidates Mr. Harish Yadav and Mr. Vijay Bhan Maurya though appeared for themselves but impersonated as Mr. Vijay Bhan Maurya by Mr. Harish Yadav and Mr. Harish Yadav by Mr. Vijay Bhan Maurya by bubbling roll number of each other

instead of themselves in the OMR answer sheet. Mr. Harish Yadav blaken the bubbles (Machine readable spots by which machine identifies the roll number of a candidate) under the digits of his roll number that of Mr. Vijay Bhan Maurya. Similarly the Vijay Bhan Maurya blaken the bubbles under the digits of the roll number that of Mr. Harish Yadav.

Therefore, it is evident that both candidates were actively involved in the crime related to *impersonation* on OMR answer sheet by bubbling roll number of each other instead of themselves, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.

In view of above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation on OMR answer sheet, cheating, forgery, connivance and conspiracy is made out against the candidates.

The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view of the above facts and circumstances, the candidature of Mr. **Harish Yadav** and Mr. **Vijay Bhan Maurya** were declared deemed to be cancelled if they has appeared in any exam conducted by DSSSB prior to above date.

Therefore, in view the above Mr. Harish Yadav S/o Ishwar Yadav having Date of Birth: 09/02/1990 bearing Roll No.: 4500003092 and Mr. Vijay Bhan Maurya S/o Sajjan Lal having Date of Birth: 04/11/1982 bearing Roll No.: 4500004804 of Post Code 14/19 are hereby debarred from any examination conducted/to be conducted by the DSSSB for lifetime w.e.f 24.11.2019. Further the candidature of Mr. Harish Yadav & Mr. Vijay Bhan Maurya will be deemed cancelled if they has appeared in any exam conducted by DSSSB prior to above date.
