ORDER

On scrutiny of biometric reports taken during the process of examination for selection of candidate against Post Code 02/17 (**GRADE-IV/ JUNIOR ASSISTANT, SERVICES DEPARTMENT**) by DSSSB, it is observed that report of biometric examination conducted during the process of examination and subsequently upon his selection to said post & joining the government service in respect of **Mr. Subhash s/o Sh. Surajbhan**, whose details are mentioned in table below, is found mis-matching indicates that candidate appeared in examination is different from the candidate joining government service. Thus, it is a case of impersonation indulging in using of unfair means in examination to achieve the employment in government by way of adopting malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the process of examination of above said post code.

Biometric examination of candidate taken at CBT and subsequently upon joining his service in government is found mismatching which indicates that different candidate has appeared in examination from the candidate performing government service. The user department has terminated his services on the basis of contradictory biometric report. <u>Thus a case of impersonation.</u>

Further, it is not out of place to mention here that the candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/ herself liable to criminal prosecution, be liable:"

- To be disqualified by the Board from the examination for which he/ she is a candidate as also from any other examination/selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or
- To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
- To take disciplinary action if he/she is already in service under Government and or,
- To take any other legal action'

Further, attention is drawn to the point no.-20 of the "General Instruction" dated 20.11.2019 for candidates for the said post code which is reproduced as under:-

"If any candidate is found using any unfair means, conspiracy, cheating, fraud, forgery, impersonation or any unlawful act he will be debarred from all examinations of DSSSB and necessary legal action will be initiated."

Thus, it is clear that the candidate had arranged to have another person taking examinations in place of him/her. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- i) Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.
- ii) Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii) Helping or receiving help from other candidates to impersonate.
- iv) Signing/ getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v) Providing admit card to another person to enable him to appear on behalf of the candidate.


Further, this candidate have also indulged in the act of **FORGERY and UNLAWFUL ACT** by altering the identity proof of candidates, admit cards etc, and produced these documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.

Therefore, it is evident that the candidate along with impersonator was actively involved in the **crime related to impersonation, cheating, forgery, connivance and conspiracy** as specified in Indian Penal Code.

In view of above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the candidates.

The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view the above **Mr. Subhash S/o Sh. Surajbhan** having Date of Birth: **14/11/1992** bearing Roll No. : 12330219385/4640003977 of Post Code 02/17 is hereby debarred from any examination conducted/to be conducted by the DSSSB **for lifetime w.e.f. 01.10.2019**. Further, the candidature of **Mr. Subhash** will be deemed cancelled if he has appeared in any exam conducted by DSSSB prior to above date.


