DSSSB has notified Typing Skill Test for the Post Code-44/21, Post Name- Junior Secretariat Assistant (LDC) in MCD on dated: 05, 06, 12, 13, 19, 20, 26, 27.11.2022, 03 & 04.12.2022 vide Notice No. F.55 (1554)/Exam/DSSSB/ 2022/1190 dated 07/10/2022 which is rescheduled to 10.12.2022 & 11.12.2022 in place of 03.12.2022 & 04.12.202 respectively due to MCD election-2022 vide Notice dated 10.11.2022.

On the day of Exam i.e. 20.11.2022 a person appeared with Admit Card issued to the candidate namely Suject Kumar along with a Govt I.D. Proof having Adhaar Card No.-451987064037 (details on Adhaar Card- Suject Kumar S/o Arjun Chaudhary; Gram-kaparsari, Post- Machhaldiha, Thana-Nalanda, Bihar-803111). After completing the details on Colour print of Photo Attendance Sheet provided by DSSSB when candidate reached the compulsory biometric verification desk before the start of typing skill test and his biometrics were taken by the Technical Team of DSSSB then it is found that both the biometrics were not matching with the person who appeared earlier for Online Written exam in name of Suject Kumar.

In view of above it is concluded that Mr. SUJEET KUMAR, whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the above said post code exam.

Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/malpractices and further, that:

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/herself liable to criminal prosecution, be liable:"

- a) To be disqualified by the Board from the examination for which he/ she is a candidate as also from any other examination/selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or
- To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
- c) To take disciplinary action if he/she is already in service under Government and or,
- d) To take any other legal action'

Further, attention is drawn to the Point No.23 of the "General Instruction to Candidates" dated 21/10/2022 issued for Typing Skill Test of Post Codes-44/21 at DSEU(Formerly BPIBS):-

"23. If any candidate is found using any unfair means or impersonation he/she will be debarred from all examination of DSSSB and/or necessary legal action be initiated."

Thus, it is clear that the candidate had arranged to have another person taking examinations in place of him/her. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.
- ii) Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii) Helping or receiving help from other candidates to impersonate.
- iv) Signing/ getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- Providing admit card to another person to enable him to appear on behalf of the candidate.

Further, this candidate have also indulged in the act of FORGERY and UNLAWFUL ACT by altering the identity proof of candidates, admit cards etc, and produced these documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.

Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.

In view of above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the candidates and a FIR No.0514 dated 20.11.2022 has also been lodged in the P.S.- Shakarpur, East Delhi, Delhi by the DSSSB.

The DSSSB adheres to ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT by any candidate or any persons. Therefore, in view the above Mr. SUJEET KUMAR S/o Sh. ARJUN CHAUDHARY having Date of Birth: 05/02/2003 bearing Roll No.: 112704414935/7300001901 of Post Code 44/21 is hereby debarred from any examination conducted/to be conducted by the DSSSB for lifetime w.e.f 20.11.2022. Further the candidature of Mr. SUJEET KUMAR will be deemed cancelled if he has appeared in any exam conducted by DSSSB prior to above date.
