ORDER

Whereas, Sh. Sunil Dangi S/o Sh. Rohtash Dangi, D.O.B. 18.10.1991 r/o Village Madina (Korsan), Tehsil : Meham, Distt. : Rohtak (Haryana) was debarred from appearing in any examination conducted / to be conducted by the DSSSB for lifetime w.e.f. 11.11.2018 vide order no. F.55(382)/Exam/DSSSB/2024/1030 dated 02.05.2024.

And whereas, Hon'ble CAT vide order dated 29.01.2026 in the matter of O.A. No. 2212/2024 titled as Sunil Dangi Vs The Chief Secretary, Govt. of Delhi & Ors. has order as:-

“Accordingly, the impugned order dated 02.05.2024, admittedly issued by the respondents without putting the applicant to any kind of notice, is therefore in violation of the principles of natural justice. Accordingly, the same is also set aside. However, liberty will remain with respondent no. 3 to consider the matter afresh but only after putting the applicant to notice”.

Therefore, in compliance of above order dated 29.01.2026 of Hon'ble CAT, the debarment order No. F.55(382)/Exam/DSSSB/2024/1030 dated 02.05.2024 issued by this branch vide which Sh. Sunil Dangi s/o Sh. Rohtash Dangi having Date of Birth: 18.10.1991 bearing Roll No. 120108920126 of CBT exam dated 11.11.2018 of post code 89/17, Post Name- Assistant Teacher (Primary) was debarred from appearing in any examination conducted/to be conducted by the DSSSB for lifetime w.e.f. 11.11.2018 is hereby withdrawn retrospectively as the fresh / revised debarment order issued vide No. F.55(382)/Exam/DSSSB/2024/E-file 332004/1195-1211 dated 19.05.2026 after following the direction of Hon'ble CAT.
