**ORDER**

On scrutiny of documents (2<sup>nd</sup> page of admit card) after receiving a requisition of Second Page of Admit Cards from CC-II Branch for Post Code 51/13 (Lower Division Clerk in Municipal Corporation of Delhi) by DSSSB, it has been found that **Mr. Vicky**, whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the above said post code exam.

Further Same Person with same photo appeared for same post code in the name of Dharmender Sahrawar (Roll No 11200600554) <b>Thus a case of impersonation.</b>

Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:

*"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/herself liable to criminal prosecution, be liable:"*

- a) To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/she might have appeared by the final result/selection has not been declared/ made and or
- b) To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
- c) To take disciplinary action if he/she is already in service under Government and or,
- d) To take any other legal action'

Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post Codes in online, offline & PET examinations.

*"If any case of impersonation comes to notice then Overall In-charge & Observer shall lodge FIR against both persons i.e. candidates who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/ Commissions."*

Thus, it is clear that the candidate had arranged to have another person taking examinations in place of him/her. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- i) Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.



- ii) Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii) Helping or receiving help from other candidates to impersonate.
- iv) Signing/ getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v) Providing admit card to another person to enable him to appear on behalf of the candidate.


Further, this candidate have also indulged in the act of **FORGERY and UNLAWFUL ACT** by altering the identity proof of candidates, admit cards etc, and produced these documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.

Therefore, it is evident that the candidate along with impersonator was actively involved in the **crime related to impersonation, cheating, forgery, connivance and conspiracy** as specified in Indian Penal Code.

In view of above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the candidates.

The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view the above **Mr. Vicky S/o Sh. Mahender** having Date of Birth: **08-Aug-94** bearing Roll No. : 11190600301 / 5200000950 of Post Code 51/13 is hereby debarred from any examination conducted/to be conducted by the DSSSB **for lifetime w.e.f 24-10-2019**. Further the candidature of **Mr. Vicky** will be deemed cancelled if he has appeared in any exam conducted by DSSSB prior to above date.
