Therefore, in view of the above facts and circumstances, the candidature of the above candidates who have appeared in the examination is hereby cancelled, on finding them involved in the acts as mentioned above in the table.

Further, the above candidates are hereby debarred from any examination being conducted by the DSSSB for a period of 15 years w.e.f. 09.09.2018 mentioned against them in the table.
