## ORDER

On scrutiny of biometric verification carried out during the process of CBT examination conducted by DSSSB on 13.06.2024 at IoN Digital Zone IDZ-2, GT Karnal Road, Plot No. 97 & 98, Khasra No. 54, Village Nangli Poona, Delhi-110036 (Centre Code – 7938) for Post Code 113/23, Warder, Delhi Prisons in respect of Mr. Sahil S/o Sh. Rohtash Singh, whose details are mentioned in table below, is found mis-matching which indicates that candidate who applied for said examination is different from the candidate appearing physically in the said examination. The candidate appearing physically in place of said Mr. Sahil S/o Sh. Rohtash Singh is found carrying the original identification documents ( PAN card & Driving License) of Mr. Sahil s/o Sh. Rohtash Singh, who further admitted that he is imposter / impersonator. Thus, it is a crystal clear case of impersonation indulging in using of unfair means in examination to achieve the employment in government by way of adopting malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the process of examination of above said post code.

Rohtash Singh and his impersonator / imposter Mr. Naresh S/o. Sh. Chander Pal R/C Village Tosham, Police Station Tosham, District Bhiwani Haryan appearing physically in place & in the name of Mr. Sahil S/o Sh. Rohtash Singh.

He admitted that he is
					appearing in the examination for other candidate. He is also an accused in above said FIR No. 100/2024, dated 13.06.2024 u/s 420, 419 & 34 IPC, P.S.: Swaroop Nagar, District: Outer North Delhi alongwith Mr. Sahil S/o Sh. Rohtash Singh, mentioned above at S. No. 1.

Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/herself liable to criminal prosecution, be liable:"

- a) To be disqualified by the Board from the examination for which he /she is a candidate as also from any other examination/ selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or
- b) To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
- To take disciplinary action if he/she is already in service under Government and or,
- d) To take any other legal action'

Thus, it is clear that the candidate had arranged to have another person taking examinations in place of him/her. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- i) Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.
- Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii) Helping or receiving help from other candidates to impersonate.
- iv) Signing/ getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v) Providing admit card to another person to enable him to appear on behalf of the candidate.

Further, this candidate have also indulged in the act of **FORGERY and UNLAWFUL ACT** by altering the identity proof of candidates, admit cards etc, and produced these documents to the examination conducting functionaries with the intent to defraud. A FIR No. 100/2024, dated 13.06.2024 u/s 420, 419 & 34 IPC, P.S.: Swaroop Nagar, District: Outer North Delhi is also registered against them.

Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.

In view of above facts and circumstances, the DSSSB has came to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the above named candidates.

The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view the above, **Mr. Sahil S/o Sh. Rohtash Singh** having Date of Birth: 29/10/2001 bearing Roll No. 231131106004868 of Post Code 113/23, Warder, Delhi Prisons, Govt. of NCT of Delhi & his impersonator / imposter **Mr. Naresh S/o. Sh. Chander Pal** R/o. Village Tosham, Police Station Tosham, District Bhiwani Haryana is hereby debarred from any examination conducted/to be conducted by the DSSSB for **lifetime w.e.f. 13.06.2024**. Further the candidature of both of them will be deemed cancelled if they had appeared in any exam conducted by DSSSB prior to above date.

This issues with the prior approval of Competent Authority.
