ORDER

Whereas, Ms. Kamalpreet Kaur D/o Sh. Satnam Singh having DoB : 22.02.1991 r/o WZ-283/7, Street No. 3, West Block, Vishnu Garden, New Delhi-110018 applied for the post of TGT (Punjabi), Female, Directorate of Education, Govt. of NCT of Delhi having post code-57/21 under Advertisement No. 03/21 dated 27.05.2021 published by the DSSSB & appeared in examination having roll No. 1128057000 & subsequently selected for said post under reserved category of SC candidate.

And, whereas Directorate of Education i.e., user department noticed some discrepancies in her SC certificate and an inquiry committee was constituted by the user department which revealed that said Ms. Kamalpreet Kaur had furnished false information and suppressed factual information in her attestation form to secure abovesaid job of TGT (Punjabi) reserved for SC category. She uploaded / submitted the unacceptable SC certificate (belonging to "Ramdasia" Caste of Delhi State) number 9510000567068 dated 04.12.2019 issued from Revenue Department, Govt. of NCT of Delhi, in order to secure selection in government job despite having OBC certificate (belonging to Luhar caste) issued from Delhi (No. 90500000206343 dated 01.03.2017 by Tehsildar, Revenue Department, GNCT of Delhi, Office of DM, West Patel Nagar. As per said OBC certificate, she belongs to OBC category (Luhar) & it was issued to her on the basis of previously issued OBC certificate No. 9058911216805 dated 29.11.2014 by S.D.M., Patel Nagar, New Delhi which was used to secure the position of guest teacher TGT Punjabi in user department i.e., Directorate of Education. Also, she has another SC certificate number 7696349 dated 29.03.2019 issued from Ludhiana, Punjab. The user department also noticed that she did not disclose about her previous appointment as guest teacher in the Directorate of Education, Govt. of NCT of Delhi in the prescribed column of attestation form as well as her CTET qualification in the year 2015 was in OBC category & later, she qualified CTET again in the year 2019 under SC category to secure regular job in the Directorate of Education, Govt. of NCT of Delhi.

And, whereas upon finding & recommendation of Inquiry Committee constituted by the user department, the services of above named candidate was terminated under provision to sub Rule (1) of Rule 5 of the Central Civil Services (Temporary Services) Rules, 1965 vide Office Order No. F.NO. DE.3(44)/DRC/E-III/TGT(Punjabi)/Female/2022/4381-87 dated 24.05.2024 issued by user department. The controlling authority of above named candidate i.e., Principal, GGSSS, Subhash Nagar, New Delhi 110027 with direction from Competent Authority of user department has requested vide her office communication dated 19.09.2024 to this board to debar the above named candidate for further exam and cancel the candidature from selection list of post code 57/21.


And, whereas it is not out of place to mention here that the candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned that stern action will be taken against candidates found guilty of misconduct.

"Action against candidates found guilty of misconduct:

Candidates are warned that they should not furnish any particulars that are false or suppress / conceal any material information while filling in the application form. Candidates are also warned that they should neither attempt to alter or otherwise tamper with any entry in document or the self attested certified copy submitted by them nor submit a tampered / fabricated document.

Without prejudice to criminal action / debarment from DSSSB's examination wherever necessary, candidature will be summarily cancelled at any stage of the recruitment in respect of candidates found to have indulged in any of the following.

- (i) Possession of mobile phone & accessories and other electronic gadgets within the premises of the examination centre, whether in use or in switch off mode or switch on mode.
- (ii) Involved in malpractices.
- (iii) Using unfair means in the examination hall.
- (iv) Obtaining support for his / her candidature by any means.
- (v) Impersonate/Procuring impersonation by any person.
- (vi) Submitting fabricated documents or documents which have been tampered with.
- (vii) Making statements which are incorrect or false or suppressing / concealment of material information.
- (viii) Resorting to any other irregular or improper means in connection with his/her candidature for the examination.

- (ix) Misbehaving in any other manner in the examination hall with the Supervisor, Invigilator or Board's representatives.
- (x) Taking away the Answer Sheet (in case of offline/online/descriptive/skill test papers) with him/her from the examination hall, or passing it on to unauthorized persons during the conduct of the examination.
- (xi) Intimidating or causing bodily harm to the staff employed by the Board for the conduct of examination.
- (xii) Not fulfilling the eligibility conditions mentioned in the Notice.
- (xiii) Candidature can also be cancelled at any stage of the recruitment for any other ground which the Board considers to be sufficient cause for cancellation of candidature.


And, whereas in view of above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of misconduct on furnishing of particulars that are false, suppression / concealment of material information while filling the application form is made out against the said candidate by the user department.

And, whereas the DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view the above, Ms. Kamalpreet Kaur D/o Sh. Satnam Singh having Date of Birth : 22.02.1991 bearing Roll No. 1128057000 of Post Code 57/21, TGT (Punjabi), Female, Directorate of Education, Govt. of NCT of Delhi is hereby debarred from appearing in any examination conducted/to be conducted by the DSSSB for **lifetime w.e.f. 06.09.2021 i.e., date of filing of application for above post code.** Further, her candidature will be deemed cancelled if she had appeared in any exam conducted by DSSSB prior to above date.

This order of her debarment shall be effective subject to outcome of court case having O.A. No. 2405/2024 titled as Kamalpreet Kaur vs. GNCTD & Ors. pending before the Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi.


