NOTICE

ASSISTANT TEACHER (NURSERY), POST CODE-88/17

IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total 320 vacancies (UR-164, OBC-88, SC-42 & ST-26 (including PH/OH-05 & PH/VH-05) for the post of **Assistant Teacher (Nursery) under Post code-88/17** in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online examination mode was conducted on **02.09.2018**.

2. Further, on the basis of online examination of Tier-1 the candidates had been shortlisted for uploading of documents in the e-dossier out of which a total of **173 candidates (UR-90, OBC-34, SC-40, ST-09, PH/OH-04, PH/VH-01), 08 candidates (UR-03, OBC-04 & ST-01), 05 candidates (UR-02, SC-02 & ST-01) and 01 candidate (SC-01)** were found provisionally eligible as per documents uploaded in support of educational qualification, age etc. in accordance with advertisement No.04/2017 and RRs for the post of Assistant Teacher(Nursery), Post Code-88/17 and were provisionally nominated vide **Result Notice No.442 dated 24/05/2019, Supplementary result notice no. 539 dated 31.10.2019, Supplementary Result Notice No. 570 dated 23.12.2019 and Supplementary Result Notice No. 607 dated 27.02.2020** respectively for the post of Asstt. Teacher(Nursery), Post Code-88/17 in Directorate of Education.

3. However, after declaration of main result the user department has returned a total of **05 dossiers under SC category** before expiry of waiting panel in this post code and in replacement of same only 03 candidates could be nominated vide **Supplementary Result Notice No. 607 dated 27.02.2020 and Supplementary Result Notice No.691 dated 12.10.2020**. Further, 02 vacancies (**SC-02**) could not be filled up even after considering all the shortlisted candidates of waiting panel under SC category .

3. Therefore, to fill up the remaining vacancies in SC category, it was decided to call the e-dossiers of the qualified candidates of online examination conducted on **02.09.2018** below the last shortlisted candidate under SC category as the qualified candidates are still available in this category only. Accordingly, the merit has been lowered to call the e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their application form.

4. The shortlisted candidates under SC Category for the above mentioned post/post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark Sheets/Caste Certificate/Disability Certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in their individual account in OARS module.



The cutoff marks for SC category candidates for uploading e – dossiers have been given as under:-

Category	SC
Cutoff marks (for uploading of e-dossier only)	74.5

5. The link for uploading of e-dossier shall be kept open for a period of 15 days w.e.f. 19.10.2020 to 02.11.2020 The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria **as on the cutoff date i.e 31.01.2018**. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. **(as an additional facility)**. If, any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.

6. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. **It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.**

7. While every care has been taken in preparing the list of shortlisted candidates for calling e-dossiers, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

10. The above short listing candidates for calling e – dossiers to the post of **Assistant Teacher (Nursery) under Post code-88/17 in Directorate of Education** is subject to outcome of pending court case, if any.
