## **ORDER**

Ms. Lajwanti D/o Sh. Rattan Lal applied for the post of ANM, Post Code-0108 in Health & Family Welfare Department, Post Code-0108 against Advertisement No. 03/2003 issued by DSSSB.

While declaring the result for the post of ANM, Post Code-0108, the selection of candidates who were having MPHW(F) Course, was kept pending as a clarification was sought from H&FW Department vide letter No. 2882 dated 01.05.06 as to whether candidates with MPHW qualification are qualified for the post of ANM for which recruitment rules prescribe "Registered Auxiliary Nurse-Midwife". The H&FW Department vide letter No. 596 dated 16.05.06 requested not to send the dossiers of such candidates who are having diploma in MPHW(F) only for appointment to the post of ANM, till finalization of Amendment Procedure. On receipt of clarification from H&FW Department, the candidature of such candidates was not considered for selection. Aggrieved with this, a candidate filed WP(C) No. 8905/2009 titled Lajwanti Vs GNCT of Delhi & Ors before the Hon'ble High Court of Delhi. The Hon'ble High Court in its judgement vide order dated 13.05.2009 has given directions "to process the case further and issue appointment letter to the petitioner subject to satisfying the other conditions and fulfilling the requisite formalities."

Accordingly, her candidature has been scrutinized to ascertain her eligibility as per Recruitment Rules and it is found that the candidate submitted OBC Certificate No. 394 dated 15.05.98 issued to her by SDM, Haryana as resident of VPO-Bohra Kalan, Tehsil & Distt-Gurgaon along with her application and not in possession of OBC Certificate issued by competent authority of NCT of Delhi. As such the benefit of reservation under OBC category is not admissible to her. Further, the candidature of the candidate is also considered in the UR category however she has scored 38.75 marks out of 120 marks and last selected candidate in UR category has scored 42.75 and all the 12 vacancies have been filled hence she can not be considered in UR category also. Therefore, the candidature of the candidate namely Ms. Lajwanti for the post of ANM, Post Code-0108 is hereby rejected accordingly.

This issue with the prior approval of the Competent Authority.
