SUPPLEMENTARY RESULT NOTICE NO.746 DATED 27.01.2021

PGT (SOCIOLOGY) MALE, POST CODE-129/17 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 DATED 20/12/2017 had advertised total 42 vacancies (UR-22, OBC-11, SC-06 & ST-03(including PH/VH-01) for the post of PGT (Sociology) Male under Post code-129/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on 19.08.2018.

2. On the basis of online examination of Tier-1 held on 19.08.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of PGT(Sociology), Post Code-129/17 in Directorate of Education, a total of 36 (UR-20, OBC-07, SC-06, ST-03, PH/VH-01) were provisionally nominated vide Result No.395 dated 28/03/2019 and 06 candidates (UR-02, OBC-04) were provisionally nominated vide Supplementary Result Notice No. 517 dated 26.09.2019.

3. Further, the User Department vide letter dated 19.03.2020 had intimated that the candidature of 02 candidates (OBC-01, SC-01) has been rejected / cancelled as they are not willing to join /not accepted offer of appointment for their respective post of PGT and requested to send the dossiers of candidates who are on the waiting panel. However, the dossiers of these two candidates were returned after expiry of waiting panel and accordingly, the candidates from waiting panel could not be considered against these two dossiers which received after expiry of waiting panel. However, the Competent Authority has approved the validity of waiting panel upto 31.12.2020.

5. Accordingly in continuation to Result Notice No. 395 dated 28.03.2019 & Supplementary Result Notice no. 517 dated 26.09.2019, the candidates detailed below are also provisionally selected on the basis of online examination of Tier-I held on 19.08.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of PGT (Sociology) Male, Post Code-129/17.

5. * The candidate bearing roll no. 2360002133 under OBC category has not done B.Ed. degree, however, as per provision mentioned in the RRs of the above post code, the qualification i.e. B.Ed. degree is relaxable in case of candidates (i) **Having obtained Ph. D. Degree in the subject concerned from a recognized University /Institute.** OR (ii) **having obtained First Division in Higher Secondary, Degree and Post Graduate Examination with the Mandatory condition that the candidate will acquire the B.Ed. /B.T. qualification within a period not exceeding three years from the date of his joining the service.** The candidate above candidate has acquired 1st division in Higher Secondary, Degree & Post Graduation and also given an undertaking that he will acquire the B.Ed. or B.T. qualification within a period not exceeding three years from the date of his joining the service. The User Department is requested to check this aspect as per RRs before issuance of any appointment letter.

6. The selection of the above 02 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various

Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

11. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

12. The recruitment process for the post of PGT (Sociology) Male, Post Code-129/17 stand closed in all respect.

13. Waiting panel was valid for a period of one year from the date of declaration of result has been expired on 27.03.2020 as per earlier result notice no. 395 dated 28.03.2019. However, the Competent Authority has approved the same upto 31.12.2020.
