The selection of the above candidate under OBC category shall further be subject to genuinity of the documents on the basis of which she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of her identity with reference to his/her photograph, signature/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after satisfying themselves of her eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. The User Department shall also get the SC/ST/OBC certificate verified from the issuing authority before his/her appointment. Further, in case of the OBC candidate, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O.M. NO. 36012/22/93-Estt. (SCT) dated 08/09/1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt. (Res) dated 14.08.2008.

It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.

**Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.**

Further, one post in respect of one candidate has been kept vacant till the finalization of case in the Hon'ble Court as the matter is sub-judice in the Hon'ble Court for a common candidate for Post Code-121/12 & Post Code- 19/13.
