The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after satisfying themselves of her eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. The User Department shall also get the SC/ST/OBC certificate verified from the issuing authority before his/her appointment. Further, in case of the OBC candidate, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O.M. NO. 36012/22/93-Estt. (SCT) dated 08/09/1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt. (Res) dated 14.08.2008.

It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.
