**RESULT NOTICE**

This is in pursuance to the directions of the Ld. Central Administrative Tribunal, Delhi vide order dated 08.05.2009 in T.A. 658/2009 [WP (C) 5154/2008] (Sapna Chahal v/s GNCT of Delhi & Ors.), 660/2009 [WP (C) 5155/2008] (Anupma Gupta v/s GNCT of Delhi & Ors.) & 699/2009 [WP (C) 1310/2008] (Vikas Rana & Ors. v/s GNCT of Delhi & Ors.) in which common issue involved in all Writ Petitions (TAs) is related to validity of Diploma issued from Shilpa Bharti Institute Affiliated from Director of College Education, Govt. of Rajasthan, Jaipur.

**RESULT NOTICE**

This is in pursuance to the directions of the Ld. Central Administrative Tribunal, Delhi in O.A. No. 1250/2009 case titled Balendu Shekhar & Ors. Vs GNCT of Delhi & Ors., which is covered by the earlier judgment of Hon'ble Delhi High Court orders dated 07.07.2008 in the case titled Nirmala & Ors. Vs GNCT of Delhi & Ors. (CWP No. 7263/2007) and similar other connected matters.

In this judgment of Hon'ble Delhi High Court has declared that petitioners hold a BFA degree awarded by Jamia Milia Islamia in Bachelors of Fine Arts, which is pursuant to a four years degree course undertaken by the petitioners, and the degree is a Hons.
