1. The candidates may please refer to the DSSSB advertisement no. 06/24 dated 05.03.2024 had advertised Total-05 vacancies including PwBD -01 under (b) sub-category) [UR-02, OBC-02 & SC-01] for the Post of Pharmacist & Junior Pharmacist under Post Code- 819/24 in Delhi Agricultural Marketing Board & Delhi Transco Limited under combined exam scheme.
2. Vide said Advertisement, under Combined Examination Scheme; it has to be ensure that – **"The candidate must exercise at least one preference for a Post. Candidates, who don't submit their Post Preference within the stipulated time, will not be considered for any Post in the final result. Such candidates shall not be provided another opportunity to exercise preference for Posts".** Further, **"Final selection and allocation of department by DSSSB shall be based on merit cum preference only. The User Department shall check the eligibility as per RRs and other terms and conditions of the Advertisement Notice".**
3. The marks obtained by **1078 candidates** who appeared in Tier-I written examination held on 09.09.2025 were uploaded on Board's website vide **Notice No. 107 dated 28.11.2025**. Out of 1078, total 22 candidates were shortlisted to select their preference of Departments and upload the documents in e-dossier module – OARS from the period **01.12.2025 to 15.12.2025** subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form. The candidates were also directed to upload duly signed PREFERENCE FORM in e-dossier module. **Out of 22 candidates total 21 candidates have uploaded their documents in OARS module.** Total 01 candidate did not upload the e-dossier within stipulated time whose candidature has been rejected vide **Rejection Notice No. 118 dated 20.01.2026**.
4. As per the provisions of Notice No. 107 dated 28.11.2025, allocations of the post to eligible candidates have been made on the basis of Merit-cum-Preference of posts submitted by the candidates in their PREFERENCE FORM uploaded in e-dossier OARS module.
5. **As per the Board (DSSSB) resolution dated 14.7.2022, DSSSB shall neither undertake scrutiny of documents uploaded by the shortlisted candidates in their e-dossier nor check the eligibility of the candidates as per the Recruitment Rules for the post or the terms and conditions stipulated in the Vacancy Notice relating to age, experience, educational qualification, reserved category status, PwBD status etc. These will be checked by the User Department at the time of Document verification for deciding the**

eligibility of the candidate for the post Code 819/24 as on **cut-off date 19.04.2024**, before issuance of offer of appointment to the candidate.

6. On the basis of marks secured in the written examination and considering other relaxations, if any, claimed by the candidates in their online application forms, **Total-04 (DAMB-UR-02, DTL-OBC-01 & DTL-SC-01)** candidates are hereby **provisionally nominated** for the Post under Post Code 819/24 subject to fulfillment of all other conditions of eligibility and also correctness of the information furnished by the candidate in his/her online applications form and e-dossier. Category wise breakup of the candidates provisionally nominated for Delhi Agricultural Marketing Board & Delhi Transco Limited under Post Code 819/24 are as follows:-

7. The provisional nomination of the above **Total-04 (DAMB-UR-02, DTL-OBC-01 & DTL-SC-01)** candidates on the basis of claims in their applications shall be subject to thorough verification of their candidature by the User Department including the identity of the candidate as per services department Circular No. F.16(3)/2007/S-III/1756-1763 dated 02/08/2021.



8. The provisional nomination of the above **Total-04 (DAMB-UR-02, DTL-OBC-01 & DTL-SC-01)** candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement and subject to thorough verification of their identity with reference to their photographs, signature/ handwriting etc. on the application form, admission certificate etc. by the User Department. **The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate does not fulfill any of the eligibility conditions of the Recruitment Rules for the post or for any genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate. The Competent Authority of the User Department concerned shall issue the offer of appointment to the candidate after being satisfied about his/her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential qualifications.**

9. The User Department shall also check the eligibility of the reservation benefit claimed by the candidates, if any. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate, if applicable. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User Department is requested to ascertain the scrutiny/correctness of the same at its own level before issuing the offer of appointment to the provisionally selected candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at its own level.

10. In case of OBC, SC, ST Candidate, the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22/93-Estt. (SCT)dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/ Circulars including order dated 07/03/2017 issued by Revenue Deptt., GNCTD after thorough verification of caste certificate.



11. User Department shall also get the SC/ST/OBC/EWS/PwBD (with sub category) certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017 and other instructions/ guidelines issued from time to time by the competent authorities.

12. In case of EWS candidates, it may also be verified that the validity of EWS certificate should be as per DOPT OM No. 36039/1/2019-ESTT(Res) dated 31.01.2019 and other instructions/ guidelines issued from time to time in this regard by the competent authorities.

13. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after verification of the correctness of the information furnished in the application form/e-dossier and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard **vide MHA OM No. 2/29/54-RPS, 19/11/54 and other relevant guidelines/ OM^s/Circulars issued by the competent authority.**

14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

15. The Department wise along with category wise marks secured by the last provisionally nominated candidates is as follows: -

17. The User Department being Cadre Controlling/ Appointing Authority shall strictly follow the merit-based ranking of the candidate in the main list.

18. The User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98- Estt (Res) dated 01/07/1998 and 430111/4/2018-Estt (Res) dated 04/03/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category, if required.


