The selection of Roll number 25002398 has been kept pending due to court case filed by Vikas Kumar (25000045) in OA no 583/2017, wherein the Ld CAT has directed to keep one UR post unfilled in post code 128/12.

Candidature of Roll number 25002351 is pending in OBC category in view of appeal filed by Board in the matter of Ram Kumar Gijroya, the candidate has furnished his OBC certificate which was issued to him after cut off date.



The selection of the above 22 Candidates shall be further subject to through verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

**In view of court case filed by Shivani Mishra vide OA no 354/2017, challenging the Tier -II Objective Paper, the above selection is further subject to outcome of the said case.**
