The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement, inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after satisfying himself of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.

Further the candidates whose roll no. find place at Sl. No. 9 in this notice was earlier nominated vide result notice no. 47 dated 23/07/2016 in reserved category. The result notice no. 47 dated 23/07/2016 stand modified so as to shift this candidate from selection against reserved vacancy in corresponding categories to the vacancy under UR quota as this candidate has now been considered under UR vacancy on his own merit. The result of this candidate under the present notice is merely change of his category as per his merit for correction of record.

It is further highlighted that as per the order of the Central Administrative Tribunal dated 22.12.2015 in the matter of Ashish Yadav Vs DSSSB in O.A. No.4631/2016, order dated 01.04.2016 in the matter of Dinesh Kumar Vs Govt. of NCT of Delhi in O.A. No. 1222/2016 and order dated 08.09.2016 in the matter of Pramod Kumar Vs. DSSSB in O.A. No. 100/3067/2016, appointments, if any, made by respondents will be subject to the outcome of the above said O.A.
