SUPPLEMENTARY RESULT NOTICE No.: 1586
WARDER (MALE) IN DIRECTORATE GENERAL OF PRISONS
UNDER POST CODE-86/2017

1. The DSSSB vide its advertisement No. 03/2017 had advertised 401 vacancies (UR-161, OBC-140, SC-70, ST-30 including ExSM-12) for the Post of Warder under post code 86/2017 in Directorate General of Prisons, with closing date 21.11.2017.
2. The e-dossiers were called from shortlisted candidate vide Notice 821 dated 25.09.2019. On the basis of documents submitted by candidate result of 389 candidates were issued vide Result Notice No. 971 dated 12.03.2020, 989 dated 10.06.2020 and 1019 dated 04.08.2020.
3. The following candidates were placed in waitlist panel of their respective category, since they were below in merit to last selected candidates of their respective category:-

4. The above applicants filed OA No. 2410/2021 in Hon'ble CAT which is allowed by Ld. Tribunal vide Order dated 27.02.2025 in OA No. 2410/2021 with following observations/directions:-

"24. We find that the DSSSB has rightly maintained the panel for one year only, however, it ought to have considered operating the same in terms of the DOP&T instructions referred to above.

25. Given the above, the present Original Application is allowed with direction to the respondent-DSSSB to consider the candidature of the applicants for appointment on the post of Warder (Male) as per their merit within six weeks from the date of receipt of a copy of this order. In case the applicant is otherwise eligible the DSSSB shall forward their dossier to user department for further action for appointment. No costs."

5. The order dated 27.02.2025 passed by the Ld. Tribunal in O.A. No. 2410/2021 was challenged in Hon'ble Delhi High Court by filing Writ Petition with W.P.(C) No. 11843/2025. The Hon'ble Delhi High Court vide Order dated 28.10.2025 in W.P.(C) No. 11843/2025, dismissed the petition filed by the DSSSB with following observations : -

"33. Therefore, vacancies which arose due to cancellation or non- joining of candidates within the validity period were required to be filled from the waitlist panel, in accordance with settled principles of fair and non-arbitrary recruitment.

34. Accordingly, no infirmity is found in the Impugned order.

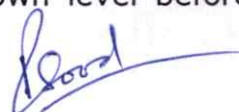
35. The petition is dismissed. The pending applications are disposed of. The parties shall bear their own costs."

6. The Department of Law, Justice & Legislative Affairs, Govt. of NCT of Delhi opined that there does not appear to be any infirmity in the Order passed by the Hon'ble High Court of Delhi.
7. In view of this, in compliance with the Order dated 27.02.2025 of Hon'ble CAT in OA No. 2410/2021, upheld by Hon'ble Delhi High Court vide Order dated 28.10.2025 in W.P.(C) No. 11843/2025 and the Legal Opinion of Law Department, GNCTD, the following 02 (Two) candidates are hereby provisionally nominated, under their respective Categories, for the post of Warder (Male) under post code 86/2017 in Directorate General of Prisons, against returned dossiers of their respective categories, subject to fulfilling all others conditions of eligibility and also correctness of information furnished by the candidate in their application forms and dossiers and following conditions: -

8. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, no scrutiny of documents in the dossier and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advt. No. 03/2017 and relaxation as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidates for the Post Code 86/2017, before issuance of offer of appointment of the post.
9. The provisional nomination of the above 02 candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department including the identity of the candidates.
10. The provisional nomination of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting, etc. in the application forms, admission certificates, etc. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application forms and the documents related to Educational Qualification, Age and other essential certificates.
11. The User Department i.e. Directorate General of Prisons shall verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the



offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidates. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidates at their own level.

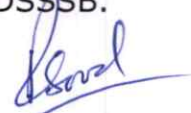
12. It is stated that the User Department shall verify the genuineness of the caste certificates furnished by the candidates, in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities, prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
13. The User Department shall also get the SC/ST/OBC/EWS certificates verified from the issuing authority before her appointment. Further, in case of OBC Candidate, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No.36033/3/2004-Estt.(Res) dated 14/10/2008 OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017 OM No. 36039/1/2019-Estt. (Res) dated 31/01/2019.
14. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about their eligibility as laid down in the recruitment Rules and after verification of the correctness of the information furnished in the application forms and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
15. The User Department shall ensure that the appointments made are in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
17. The recruitment process for the Post of Warder under post code 86/2017 in Directorate General of Prisons has already been closed. Further, the Wait List panel of the candidates had already been expired.



18. Mere inclusion of the name of candidates in the result notice does not confer any right upon the candidates over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidates are suitable in all respect for appointment to the Post.
19. The nomination of the candidates is subject to outcome of review petition filed in the matter, if any. Further, the User Department shall also ensure that subsequent appointment and any other action will be subject to outcome of review petition/court case filed in the matter at any stage.
20. However, the candidature of the following candidate cannot be considered for nomination for the post of Warder under post code 86/2017 in Directorate General of Prisons, in OBC Category as he does not come in merit as there are still 19 candidates above him in waiting list of OBC Category who are not selected: -
