NOTICE

Subject:- Declaration of Result of skill test & Uploading of e-dossier from the shortlisted candidates for the Post of Asstt. Grade-III in DTL under post code-57/13 – regarding.

The DSSSB vide its advertisement No. 03/2013 had advertised 38 {UR-02, OBC-27, ST-09 including PH (OH)-01} for the post of Asstt. Grade-III, Post Code-57/13 in Delhi Transco Limited. A written examination was held on 24.09.2017.

- 2. The marks obtained by 1939 candidates who duly appeared in examination conducted on 24/09/2017 have already been uploaded on the Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 3. Further, as per Recruitment Rules and clarification provided by the user department, a computer based skill test of the qualified shortlisted candidates was held w.e.f. 04.01.2019, 05.01.2019 & 06.01.2019. The Result of skill test (typing test) of the shortlisted candidates who qualified/not qualified the skill test was also uploaded in OARS module.
- **4.** Further, on the basis of qualifying of the skill test, the candidates were shortlisted and asked for uploading of documents in the e-dossier w.e.f. 13/09/2019 to 27/09/2019 vide notice dated 11.09.2019.
- 5. Thereafter, the result of the post of Asstt. Grade-III in DTL post code-57/13 was declared vide result notice no. 546 dated 25.11.2019 vide which out of 38 notified vacancies, a total of 29 candidates had been nominated and remaining 09 vacancies OBC-04, ST-04 remained unfilled due to non-availability of the candidates who qualified skill test held on 04.01.2019, 05.01.2019 & 06.01.2019.
- 6. Therefore, to fill up the remaining unfilled 09 vacancies, the more qualified candidates below the last selected candidate in merit were shortlisted for skill test (typing test) which was held on **04.01.2020**.
- 7. Now, the candidates appeared in skill test (typing test) held on 04.01.2020 who qualified/not qualified the skill test may check their status in their account in OARS module.
- **8.** Further, on the basis of qualifying of the skill test, the candidates have been shortlisted for uploading of documents in the e-dossier.
- 9. Based on the performance in the skill test, a total of 21 candidates who obtained marks above or equal to cutoff marks in their respective categories and qualified the skill test, as detailed below, have been provisionally shortlisted to upload e-dossiers subject to attaining

minimum qualifying marks and correctness of the information furnished by the candidate in their online application forms

10. The category wise cutoff marks (who have qualified skill test) for uploading e-dossier have been given as under:-

- 11. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module. Short listing is being made on the basis of marks obtained in Tier-I written examination (Objective-MCQ) for 200 marks & skill test (typing test) in qualifying nature.
- **12.** Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- 13. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time.
- 14. The e-dossier link shall be activated for a period of 15 days w.e.f. 28/07/2020 to 11/08/2020.
- 15. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 18.10.2013 as per Advertisement No. 03/13. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. (as an additional facility). If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 16. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
