1. The DSSSB vide its advertisement No.02/25 had advertised **Total-01 vacancy [UR-01]** for the post of **Chief Accountant** under Post Code- 36/25 in Urdu Academy.
2. The written examination (online mode) was conducted on **01.05.2026**.
3. The marks obtained by **320 candidates** who have duly appeared in examination (online mode) held on **01.05.2026** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssonline.nic.in**
4. Based on the performance in the Tier-I written examination (online Mode), a total of **100 candidates** who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II Exam, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II Exam separately.

Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Tier-II Exam does not entitle them any right over the post.
6. As per the Board Policy the minimum qualifying marks in one Tier written examination for UR & EWS Category Candidates is 40%, for OBC candidates is 35% and for SC, ST & PwBD candidates is 30%.
7. **The details of Tier-II Exam shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.**
8. The above short-listing for Tier-II Exam for the post of **Chief Accountant** under

POST CODE-36/25 in Urdu Academy will be subject to outcome of pending court cases, if any.
