

**REVISED RESULT NOTICE NO 247**

Versus DSSSB & Ors.

For the vacancies earmarked for different reserved categories i.e. OBC the reservation benefits have been considered as admissible earmarked for different reserved categories i.e. OBC, the reservation benefits have been considered as admissible in accordance with the related instructions of the GNCT of Delhi.

The above nominations are purely provisional and subject to the approval of the competent authority of the User Department for which application and necessary documents as received from the candidates have been placed in the dossier of the candidates.

The selection of above 38 candidates (UR-15(including 01 EXSM), OBC-15, SC-08 shall be further subject to fulfillment of all eligibility conditions as prescribed by the statutory RR's & terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of his identity with reference to his photographs, signatures, handwriting etc. on the application form, admission card, etc by the User Department. The candidature of the candidate is liable to be cancelled by the User Department also, in case the candidate is not found fulfilling the eligibility conditions or any other genuine reasons. The competent authority of the User Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post. The selection/appointment of above mentioned candidate shall further be subject to outcome of any court case filed by any of the candidates whose candidature has been cancelled.
