RESULT NOTICE (PART-V) STAFF NURSE (POST CODE-20/13) GOVT. OF N.C.T. OF DELHI

In continuation of Result Notice (Part-I, II,III & IV) vide office order No. 325 (Part-I) dt. 29/04/2014, Result Notice (Part-II) vide office order No. 332 dated 25.06.2014 and Result Notice (Part-III) vide office order No. 348 dated 30.12.2014 and result notice (Part- IV) office order No. 361 dated 20.03.2015 on the basis of written examination held on 09/06/2013 and eligibility regarding educational qualification, age etc. as per Advertisement No. 01/13 and RRs for the post of Staff Nurse (Post Code No. 20/13), and further clarification regarding qualification provided by the H&FW Deptt., Govt of NCT of Delhi, the following candidates are provisionally selected and recommended for appointment to the post of Staff Nurse (Post code 20/13) in H&FW Deptt., Govt of NCT of Delhi. The verification & collection of documents were carried out by the staff deployed from the User Deptt i.e. H&FW Deptt and thereafter the collection of documents were carried out by the staff of DSSSB at Board's office on 22/05/2014, 23/05/2014, 02.09.2014, 22.09.2014 & 23.09.2014 for the pending, absentee, OBC(D), EXSM, OH(OL) candidates etc.

At this stage, the result of those candidates who come in the merit and fulfill all the eligibility criteria for the provisional selection, are hereby declared. Pending result of the remaining candidate & waiting list for SC/ST candidates will be declared later on for all post codes of Staff Nurse.

As per decision of Board, based on the clarification received from the Services Department, Govt. of NCT of Delhi all such candidates whose result was withheld for the reason that they belong to SC/ST (outsider) category are eligible for reservation to the post, which are reserved for SC/ST candidates. Therefore, their result is being declared as per the current policy on reservation dated 10/05/2013 based upon case of Deepak Kumar (WPC No. 5390/2010). They are provisionally selected subject to fulfilment of all other conditions as described in RRs provided by the User Department as on cut-off date.

POST CODE 20/13 :-

The Board is declaring the part-V result for the Post code 20/13 of 06 candidates (UR-01, SC-04 & ST-01) and waiting list of (UR-78)candidates details mentioned as under and final list and waiting list of SC/ST will be declared later on after receiving the clarification from Service Department regarding caste certificate issued after cut-off date submitted by the candidates. DUE TO 08 PENDING CANDIDATES WAITING LIST IS NOT PREPARED.

The provisional selection of the above candidates (UR-1, SC-04 & ST-01) shall further be subject to fulfilment of all the eligibility conditions as prescribed by the statutory RRs and terms and conditions of advertisement as indicated in the advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/ handwriting etc. on the application form, admission certificate etc. The User Department shall also check the claims of age relaxations on account of experience and verify the certificates produced by them and decide on such relaxation as per various clarifications issued by the H&FW Department. The Health & Family Welfare Deptt., GNCTD vide letter No. F. No. 8/102/TRC/H&FW/2009/14758 dated 11.06.2014 has clarified with regard to essential qualifications required for the post of Staff Nurse, however, being a technical post, the User Department is required to clearly verify the required prescribed educational qualifications for being in accordance with the RRs & the subsequent clarification provided by the H&FW department & only after their due satisfaction to issue the appointment letters. If any, essential qualification is not as per the provisions of the RRs, the candidature of the candidates are liable to be cancelled by the User Department. The Competent Authority of the department concerned shall issue the appointment letter to the candidate after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information/documents/caste certificate furnished in the application forms. Further, the recognition of the universities/institutes from where the degrees/diplomas/certificates have been submitted by the candidates should also be verified by the User Department. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

The User department shall also get the OBC certificates verified from the issuing authority before his/her appointment. It may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. Of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993 O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt. (Res) dated 14.08.2008.

- 1. All the UR candidates to please note that there is only Two (02) vacancy kept unfilled due to court case.
