Whereas, the candidate bearing Roll No. 2700000265 under UR category was an opportunity w.e.f. 17/06/2020 to 26/06/2020 to upload the documents regarding experience certificates of Guest/Contract Teacher issued by Directorate of Education.

- 2. Whereas, the said candidate has uploaded the documents regarding her experience of Guest/Contract teacher as follows:-
- 1. w.e.f. 18/09/2014 to 08/05/2015 of 134 days
- 2. w.e.f. 01/07/2015 to 28/05/2016 of 222 days
- 3. w.e.f. 04/07/2016 to 03/06/2017 of 209 days.
- 3. Whereas, as per circular of Education Department with regard to Guest /Contract Teachers- Relaxation in the upper age limit as a onetime measure upto the actual time spent as guest/contract teacher in Dte. Of Education, subject to a maximum of 05 years provided they have worked for atleast 120 days in that particular year. (this would be applicable to those guest/contract teachers who have worked for the academic years 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17.
- 4. The relaxation in age of 02 years for the period of w.e.f. 01/07/2015 to 28/05/2016 of 222 days & w.e.f. 04/07/2016 to 03/06/2017 of 209 days has been considered but the period w.e.f. 18/09/2014 to 08/05/2015 of 134 days is not clear as academic year for this period would be 01.04.2014 to 31.03.2015 whereas 134 days has been completed by the candidate on 08.05.2015 which also includes excess period of one month and eight days after 31.03.2015, therefore, after deducting this excess period, net effective period i.e. 2014-15 will be less than 120 days. Hence, one year experience cannot be considered for the academic year 2014-2015 which is less than 120 days.
- 5. Whereas, after considering the 02 years experience as Guest/Contract Teacher, the candidate is still 09 months 26 days overage. Hence, the candidate bearing Roll No. 2700000265 is being given 05 days 2<sup>nd</sup> and final opportunity w.e.f. 02/09/2020 to 06/09/2020 to upload the above requisite documents in the e-dossier, failing which her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 6. The e-dossier module link for the above candidate shall be activated w.e.f. 02/09/2020 to 06/09/2020.
