In compliance of order of Ld. CAT. Dated 19.07.2013 as passed in OA No. 1599/2012 and 2691/2012 case titled Ms. Meenu Kumari V/s MCD & Ors. and Ms. Sunita Devi V/s MCD & Ors. respectively, the candidates with following particulars have been provisionally selected/ nominated to the post of Teacher (Primary) in MCD, in the pay scale of Rs.4500-7000 (Pre-revised) under post code 0165/07.

The selection against advertised vacancies in above post code was processed by the Board and result was declared vide Result Notices dated 25.09.2008, 07.01.2009 and 17.04.2009 as per merit drawn on the basis of part-II written examination held on 15.06.2008. The vacancies had been advertised by the Board as per requisition of MCD vide advertisement No. 08/2007 with closing date of receipt of application as 29.10.2007.

The selection of the above 02 (Two) candidates under OBC category shall further be subject to fulfillment of all eligibility conditions as prescribed in the statutory RR's & terms and conditions of advertisement as indicated in the advertisement inviting applications and direction of Hon'ble Court and also subject to thorough verification of their identities with reference to her photograph, signature and handwriting etc, on the application form, admission certificates etc. by the user department. The candidature of the candidate is liable to be cancelled by the user department also, in case candidate is found not fulfilling the eligibility conditions or any other genuine reason. The Competent Authority of the user department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. **Further, in particular, the user department i.e. MCD will ensure the eligibility with regard to age relaxation to be allowed to each candidates as per the service rendered as contractual teacher as on 29.10.2007 as per direction of Hon'ble High Court in para 13 & 14 of the order in WP© 1641/2011 titled DSSSB V/s Preeti Rathi befor offer of appointments.** The selection/ appointment of above mentioned candidates shall further be subject to outcome of any court cases filed by any of the candidates whose candidature has been cancelled. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The user department shall also get the OBC certificate verified from the issuing authority before his appointment. Further, it may also be verified that the candidate does not belong to the person/section (Creamy Layer) mentioned in column 3 of the schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt.(Res) dated 09.03.2004 and O.M. No.36033/3/2004-Estt.(Res) dated 14.10.2008.
