**CORRIGENDUM**

This is in partial modification of office order No. 84 dated 16.12.2005 vide which 03 SC and 07 ST candidates were selected as LDC in Post Code-102/2000 in Slum & JJ (MCD) and their dossiers were forwarded to the user Department. The user Department has returned a dossier of Sh. Om Prakash Meena (Roll No. 55058946) who was selected under ST category, with the reason that the candidate has not been found eligible as per the recruitment rules. Second option of the candidate is Govt. of NCT of Delhi, Post Code -101/2000.

As such, candidature of Sh. Om Prakash Meena is hereby cancelled from Slum & JJ (MCD), Post Code-102/2000 and provisionally recommended for appointment under Scheduled Tribe category as Grade-IV (DASS) in Post Code-101/2000 in Services Department, as per second option of the candidate. Details of the candidate are given as under:

The chronological processing of selection of the candidate is enumerated as under:

1. Last date of receipt of application was 27.11.2000 vide Advertisement No. 03/2000.
2. Part - I Exam was held on dated 25.02.2001 & 04.03.2001 and Part-II Exam on dated 11.08.2003 also skill test conducted by the Board on dated 04.09.2005.
3. Final result was declared on dated 16.12.2005 for above said post.
4. Dossier was sent to P & P Branch for further submission to Slum & JJ Department (MCD) vide letter dated 20.12.2005.
5. The dossier was received back in the Board on dated 27.06.2007 from Slum & JJ Department (MCD) vide letter dated 26.06.2007 with the reason that Sh. Om Prakash Meena has not been found eligible as per the recruitment rules prevailing in Slum & JJ Department (MCD). Dossier of the candidate was recommended to the Slum & JJ Department (MCD) as per 1<sup>st</sup> option of the candidate and his qualification was treated 2<sup>nd</sup> division (47.72%) at graduation level but the same has been rejected by the user department as mentioned above.

6. The candidate made a representation to the National Commission for Schedule Tribe, from where a reference was received in DSSSB in August, 2008. DSSSB sought consent of Services Department vide letter dated 23.02.2009. The Services Department vide letter dt. 13.04.2009 intimated that DSSSB may take appropriate decision in this matter as per rules & norms followed by them at their level under intimation to this deptt. with details of the candidate. Accordingly dossier of the candidate is being sent for further necessary action.

The appointment of the candidate is subject to fulfilment of all conditions of eligibility for the post applied for, submission of documents and also the correctness of information submitted by him in his application form. The **Competent Authority of the department concerned** shall issue the appointment letter to the candidate after satisfying themselves of his eligibility as laid down in the recruitment rules.
