to resignation of selected candidates within one year of joining the post, shall be filled up from this reserve panel/waiting list.

Further for benefit of reservation to SC category candidates result has been processed as per judgment of Hon'ble High Court passed in WP(C) No. 5390/2010 titled Deepak Kumar Vs Distt. Session Judge, letter dated 10.5.2013 issued by Spl, Secretary (Services) regarding reservation policy to be followed by with regard to SC/STs in the civil posts under GNCTD and judgement of Hon'ble High Court in WP© 3049/2012 titled Ravindra Devi Vs. GNCTD & Ors, . The OBC category candidates with certificate of Delhi Origin issued by the Competent Authority of Govt. of NCT of Delhi only have been considered for admissibility of benefit of reservation. In respect of some OBC candidates who had obtained the OBC certificate recently but whose education is from other states, their selection in OBC category is being processed subject to the verification of their cast certificate by the user department.

The selection of the above (24) Twenty Four (55/10-UR-7,OBC-4 Total:11) (56/10-UR-8,OBC-4,SC-1=13) candidates shall further be subject to candidate's fulfilling the eligibility conditions of the post, as prescribed by the statutory Recruitment Rules and terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of their identity with reference to their photograph, signatures and handwriting etc., on the application form, admission certificates etc. by the user department. The candidature of the candidate is liable to be cancelled by the user Department also, in case candidate is found not fulfilling the eligibility conditions or any other genuine reasons. The Competent Authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The user department shall also get the SC/OBC certificates verified from the issuing authority before his/her appointment. Further case of the OBC certificate, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India DOPT O.M No. 36012/22/93-Estt.(SCT) dated 8.9.1993 O.M. No. 36033/3/2004-Estt.(Res.) dated 09.03.2004 and O.M No. 36033/3/2004-Estt.(Res) dated 14.8.2008
