The selection against advertised vacancies in above post code was processed by the Board and result was declared vide result notices dated 06.10.2009, 21.12.2009, 26.05.2010, 07.06.2010, 01.09.2010, 27.10.2010, 10.02.2011 and 20.06.2011 as per merit drawn on the basis of Part-II examination (Descriptive) held on 15.02.2009. The vacancies had been advertised by the Board as per requisitions of Municipal Corporation of Delhi vide advertisement No. 02/2008, with closing date of receipt of application as 12.08.2008.

The selection of the above 01 (one) candidate under OBC category shall further be subject to fulfillment of all eligibility conditions as prescribed in the statutory RR's & terms and conditions of advertisement as indicated in the advertisement inviting applications and direction of Hon'ble High Court and also subject to thorough verification of their identities with reference to her photograph, signature and handwriting etc, on the application form, admission certificates etc. by the user department. The candidature of the candidate is liable to be cancelled by the user department also, in case candidate is found not fulfilling the eligibility conditions or any other genuine reason. The Competent Authority of the user department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. The selection/ appointment of above mentioned candidate shall further be subject to outcome of any court cases filed by any of the candidates whose candidature has been cancelled. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The user department shall also get the OBC certificate verified from the issuing authority before her appointment. Further, it may also be verified that the candidate does not belong to the person/section (Creamy Layer) mentioned in column 3 of the schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt.(Res) dated 09.03.2004 and O.M. No.36033/3/2004-Estt.(Res) dated 14.10.2008.
