- 6. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/08/2008.

- 7. The candidate having roll number 2830000720 who were earlier selected in OBC category vide Result Notice No. 772 dated 19/03/2013 has now been shifted to the UR Category as he was at UR WL 1.
- 8. The Candidate having roll no. 2830002920 who was earlier at UR WL 2 has now been selected in UR Category.
- 9. The Candidate having roll no. 2830000247 who was earlier at OBC WL 1 has now been selected in OBC category due to shifting of candidate having roll no. 2830000720 from OBC to UR Category.
- 10. If the candidate has any grievance regarding his/ her educational qualification/ age etc., he/she may approach the user department i.e. Services Department, GNCTD for necessary clarifications as the eligibility has been checked as per the terms & conditions provided by the user Department.
- 11. The result is subject to the outcome of the court cases pending in various courts related to this post.
