UNDER POST CODE 191/2014 (REVISED)

In the Result Notice no 403 dated 22.06.2016, where by result for the post of *Post Graduate Teacher (Urdu) (Female)* in Directorate of Education under post code 191/2014 in the pay scale of Rs. 9300-34800 having Grade Pay of 4800/- (Non- Gazetted) was declared, it has been found that Ms Saima having Roll number 38000120 was shown shortlisted in Tier I Examination under OBC category, whereas she had been shortlisted under the UR category in Tier I examination.

On the basis of the merit list of Tier- II examination held on 28.06.2015 and after determining eligibility for the post as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, Ms Saima's candidature should have been considered under UR category instead of OBC category.

Accordingly the result notice no 403 dated 22.06.2016 is hereby rescinded and the following candidates are provisionally selected to the post of PGT (Urdu) Female under post code 191/2014, as per the revised result which is as under:

The selection to the above 02 Candidates shall be further subject to the through verification of the candidature of the candidate by the User Department including the identity of the candidate with reference to her photograph, signature, handwriting and thumb impression etc on the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be the final and binding on the DSSSB and the Board.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ document as furnished in the application form vis-à-vis from the original documents.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
