In view of above result of the candidate having Roll Number ~~2200~~7575 is purely provisional subject to verification by the user department prior to issue of offer of appointment and satisfaction of the user department that the candidate fulfills the educational qualification as on cut off date i.e. 15.06.2012 in view of remarks mentioned against him.

6. The selection of the above 01 Candidate shall be further subject to thorough verification of the candidature of the candidate by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

7. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

8. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

9. Further, the above selection is subject to outcome of cases titled **Anil Kumar Vs GNCTD in OA No 4114/17 and Dinesh Kumar Vs GNCTD in OA No 186/18.**



10. The selection of 67 candidates selected vide result notice number 585 dated 22.12.2017 is also subject to the outcome of case titled Anil Kumar Vs GNCTD in OA No 4114/17.
