## RESULT NOTICE NO- 704 POST GRADUATE TEACHER (HINDI) (FEMALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 137/2012

- 1. The DSSSB vide its result notice number 584 dated 22.12.2017 and number 595 dated 16.02.2018 has declared the result of 76 candidates for the post of Post Graduate Teacher (Hindi) (Female) in Directorate of Education under Post code 137/12.
- The candidature of the candidate having Roll Number 22000039 was pending in VH/UR category for consideration of her representation. In this regard it is stated that on detailed examination of her it has been noted that the candidate had applied manual application form for the post of PGT (Hindi) under postcode 137/12 under VH/UR category. However in the available data for postcode 137/12 her category was wrongly shown as 'UR' due to some error in data feeding for postcode 137/12, as such the category as mentioned by the candidate in postcode 137/12 is hereby considered as VH/UR.
- 3. Further candidate having Roll no 22000170 whose candidature was pending for want of her disability certificate, has furnished the requisite documents.
- 4. On the basis of the merit list of Tier- II examination, additional documents furnished by the candidate whose candidature was pending and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Hindi) Female Post code 137/2012:

- 6. The candidature of candidate having 22000039 is pending in UR/VH category for obtaining the requisite documents from the candidate through edossier.
- 7. The selection of the above 01 candidate shall be further subject to thorough verification of the candidature of the candidate by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 8. The candidate who have availed the benefit of the reservation at the time of shortlisting of candidate for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 9. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 10. Further, the above selection is subject to outcome of cases titled Anil Kumar Vs GNCTD in OA No 4114/17, Yogesh Sharma Vs GNCTD in OA No 4146/17 and Dinesh Kumar Vs GNCTD in OA No 186/18.
- 11. The selection of 63 candidates collected vide result notice number 584 dated 22.12.2017 is also subject to the outcome of case titled Anil Kumar Vs GNCTD in OA No 4114/17.
