## RESULT NOTICE NO- 70 | POST GRADUATE TEACHER (HINDI) (FEMALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 170/2014

- 1. The DSSSB vide its result notice number 598 dated 19.02.2018 has declared the result of 18 candidates for the post of *Post Graduate Teacher (Hindi) (Female)* in Directorate of Education under **Post code 170/12.**
- **2.** The candidature of the candidate having Roll Number 22005106 and 22000161 was pending for requisite document. Now the candidates have furnished the requisite documents.
- 3. The candidature of the candidate having Roll Number 22006920 was pending in UR category for requisite document regarding age relaxation. Now the candidate has furnished the requisite documents, which indicates that the candidate is working in MCD. In view of the DOPT OM number 15012/2/2010-Estt(D) dated 27.03.2012 the age relaxation application to central government civilian employees holding civil posts are not applicable to personnel working in autonomous/statutory bodies. Accordingly the candidate having roll number 22006920 is not eligible to seek the 05 years age relaxation as admissible to government employees thus is overage in UR category, therefore her candidature is hereby rejected. The next available candidate in merit list is considered against the vacancy kept pending for her.
- **4.** On the basis of the merit list of Tier- II examination, additional documents furnished by the candidate whose candidature was pending and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Hindi) Female **Post code 170/2014**:

- 7. The candidates who have already been selected for the post of Post Graduate Teacher (Hindi) under post code 137/2012 as per their merit, have not been considered again for selection in postcode 170/2014, as the DSSSB has conducted the combined examination for the post of 137/2012 and 170/2014.
- 8. The selection of the above 03 Candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 9. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.



- Mere inclusion of the name of the candidate in the Result Notice does not 10. confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- Further, the above selection is subject to outcome of cases titled 11. Anil Kumar Vs GNCTD in OA No 4114/17, Yogesh Sharma Vs GNCTD in OA No 4146/17 and Dinesh Kumar Vs GNCTD in OA No 186/18.
