The number of candidates selected for appearing in Tier-II Exam has been worked out in the ratio 1:10 in relation to the advertised vacancies, taking all the candidates who have scored marks equal to the cut off marks for each category for short listing. Final selection against advertised vacancies shall be made in accordance with the merit list drawn as per result of the written examination subject to availability of vacancies and the candidates qualifying the Tier-II Exam and also fulfilling all conditions of eligibility as prescribed by the RRs of the User Department and terms & conditions of advertisement.

Shortlisted candidates whose Roll Numbers are indicated in this notice will be called for Tier-II Exam separately.

For preparation of merit list, date of birth, Category, Subcategory specified by the candidate in OARS has been considered.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.

Note: OBC (Other State) candidate have been treated as UR candidate.
